Prime Rating

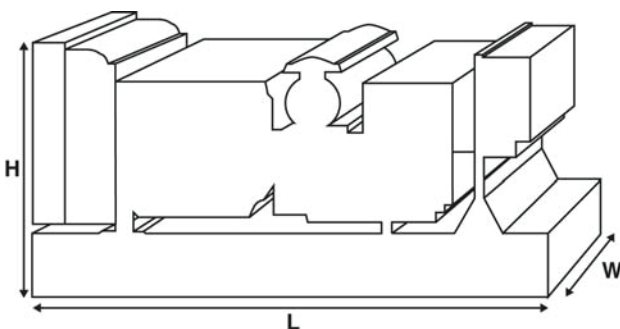

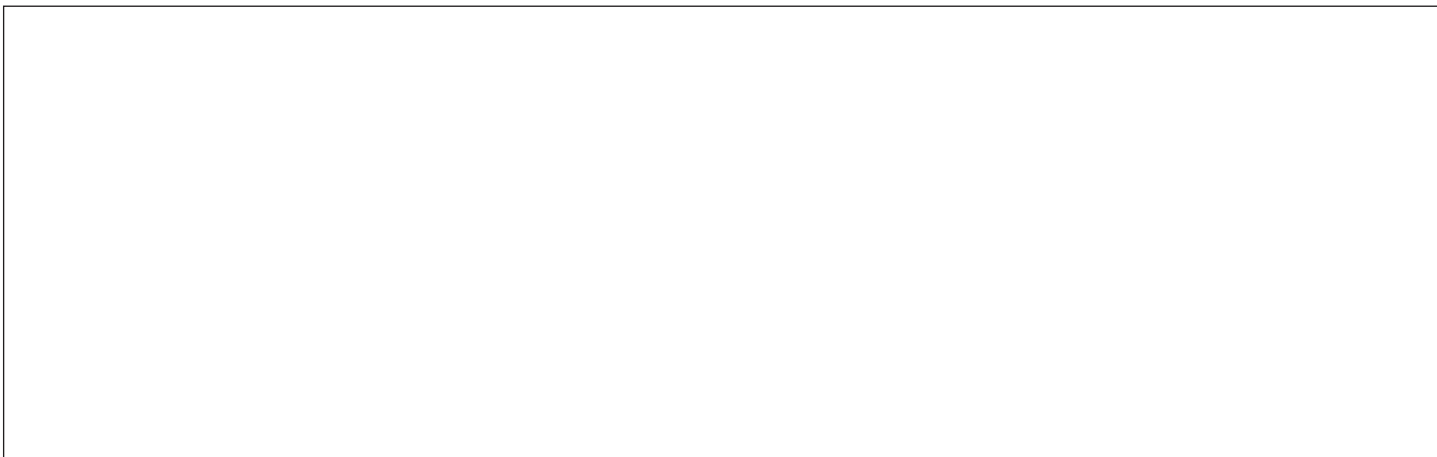
