Prime Rating

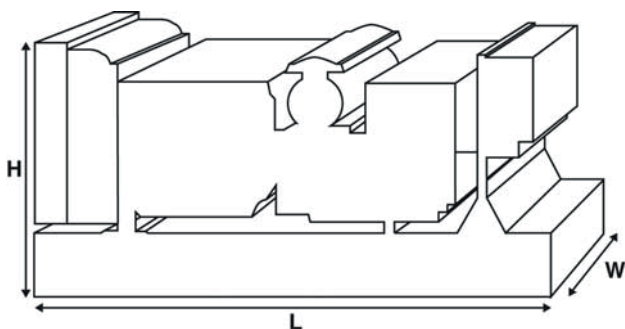
