



Basketball League Registration Meeting—October 22

The Registration Meeting for Caterpillar employees and retirees to register teams for recreational basketball will be held on Thursday, October 22, at 4:30 p.m. in the Administration Building's conference room SL-D (Service Level—D Wing). Employees not badged for the Administration Building will need to check in at the Security Office on Washington Street.

Caterpillar employees, retirees and their spouses are eligible to participate.

The team captain (or assigned representative) must attend the mandatory Registration Meeting to submit the team registration form and check or money order made payable to Caterpillar Inc. for \$125. No cash please. Registration is by team—not individual

players. Leagues begin in early January. Team player names are not required for the meeting. Individual players who do not have a team organized may e-mail socialactivities@cat.com with name and telephone number before October 20. Names will be given to captains at the meeting and individuals will be contacted by the captains if players are needed.

To create your own team, gather coworkers and send a Team Captain (or representative) to the Registration Meeting. League rules (including eligibility) can be found at <https://socialactivities.cat.com> under Athletic Leagues.

For reference, over the past few years, games have been played Monday through Thursday nights.

SOFTBALL LEAGUE COMES TO A CLOSE

While the weather this summer was unseasonably wet which caused many rainouts, over 570 employees, retirees and their spouses enjoyed exercise and recreation during the Caterpillar Softball League. The league ran from May through August and fielded 31 teams with games played Monday through Thursday nights at Oak Ridge Park in Washington. While the entire league is recreational, there was one team that ended the season undefeated—Big Iron (Tuesday night).

For decades, Caterpillar has sponsored athletic leagues to encourage employees to engage in fitness activities and to provide ways to interact with other employees in a social setting.

Online Registration

When registering for a Social Activities event using the online registration system, the following steps must take place:

1. All attendee names must be registered—not just the employee/retiree. Continue selecting "Add Registrant" until all attendees are registered.
2. Payment must be made (either by credit card or PayPal) before the registration is finalized. *If this step is not completed, the registration **has not** been processed.*
3. An immediate automated email confirming payment was processed will be sent. *If the email isn't received, the registration was not processed.*
4. Social Activities will send a confirmation email closer to the event date providing additional details. The confirmation email will be sent to the email address provided during online registration.
5. If an immediate payment confirmation email (#3) and a registration confirmation email (#4) are not received, the online registration was not successful.
