What coverage is available for Cat® Reman Engines?

Reman coverage for (complete) engines in Electric Power applications complements the long and short block coverage we currently offer. It provides you with additional repair options and quicker turnaround times to get your gensets back up and running.

What Reman Engines are offered?

Available Cat Reman Engines range from C18 to 3516B HD for Electric Power genset applications at 50 or 60 Hz.

Since generator ends are not serviceable, are Reman generator ends available off-the-shelf through the dealer?

Yes, Reman generator ends provide an off-the-shelf solution so you can avoid the lengthy processing time required by a generator rewind shop.

Why should I buy Reman generator ends?

Reman generator ends are remanufactured in a factory environment with Caterpillar controlled processes and are tested with the same rigor as a new Cat generator end. Reman generator ends come with a same-as-new parts warranty and are sold at a fraction of the new part cost. All are shipped without a "doghouse" providing more flexibility for your application.

What if I have a genset with an engine part number that is not listed?

Reman Engines are offered to serve a range of power requirements. Contact your Cat dealer with your current serial number to review the feasibility of using one of the Reman Engines available.

REMAN LONG AND SHORT BLOCKS

What's included in a Reman Long or Short Block?

Cat Reman Short Blocks include a cylinder block, crankshaft, pistons and connecting rods. Long Blocks are short blocks with a cylinder head, camshaft, timing gears, lifters and oil cooler.

Cat Reman Long and Short Blocks are disassembled, thoroughly flushed to meet rigid cleanliness standards and 100% inspected for cracking, erosion or other damages. Block and cylinder head faces are resurfaced to factory specifications. Crankshafts are reground, polished and checked for lift endplay. All bearings, seals, gaskets and piston rings are replaced with new Cat parts. Blocks are tested electronically to ensure consistent quality and long life.

What engine models are covered by the Reman Long and Short Blocks?

Contact your local Cat dealer for a list of available Reman Long and Short Blocks.

Will the Reman Long and Short Blocks affect the emission level of my engine?

No, the Reman Long and Short Blocks will not affect the emission level of your engine. Fully assembled and ready to be built into your engine, long and short blocks are factory remanufactured using genuine Cat parts and include all critical engineering updates — so they deliver like-new performance and long life.

Our simple Core Acceptance Criteria allows a quick assessment of your core credit. Your dealer visually inspects the core when you bring it in, providing an immediate decision on condition and credit, so you don't have to wait for — or guess — the repair costs. Plus, our two-level pricing system ensures a partial refund for non-running engines or non-functioning blocks: visibly broken, cracked or welded, or with evidence of internal failure.
