ALCOR™ BRAZING FILLER METAL

DESCRIPTION:

Alcor™ is a zinc-aluminum brazing filler metal designed for low temperature joining of aluminum base metals. Typical aluminum braze alloys melt and flow very close to the base metal melting temperature. Alcor's lower operating temperature reduces the possibility of overheating the aluminum part.

Alcor is a flux cored wire. This eliminates the need to separately flux the part. Alcor's flux residue is non-corrosive so post braze flux removal is unnecessary.

Alcor is a good choice for joining aluminum alloys of the 1000, 3000, and 6000 series. It can also be used to join aluminum to copper. For dissimilar metal applications the long term galvanic corrosion potential should be considered and a protective joint coating may be required.
