# The 2018 "This is my Thrill" Giveaway (the "Sweepstakes")

### **OFFICIAL RULES**

I accept the terms and conditions as set forth in these Official Sweepstakes Rules ("Official Rules"). I confirm I am at least 18 years old.

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ENTRY IN THIS SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES. EACH PRIZE WINNER IS ONLY ELIGIBLE TO WIN ONE PRIZE IN THE SWEEPSTAKES.

## 1. Eligibility:

You must be 18 years or older and a legal resident of any of the Contiguous 48 United States or the District of Columbia (the "Territory") and have a valid email address at the time of entry. Void where prohibited or restricted by law. Void in overseas U.S. territories, possessions, commonwealths and military installations, and where prohibited or restricted by law.
