Ready-to-Use Spray **Stink Bug Killer**



DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

GENERAL INFORMATION: This product is long-lasting and keeps on killing for up to 4 months after you spray. Contact kill gives you immediate results when spraying insects directly, while residual activity kills insects when they return to treated areas. This product will not stain surfaces or fabrics. This product is intended to be used in and around residences and their immediate surroundings such as (but not limited to): apartments, attics, basements, bathrooms, cabins, campers, carports, decks, garages, gazebos, kitchens, patios, porches, storage areas, utility rooms and verandahs. Do not use in commercial food handling establishments, restaurants or other places where food is commercially prepared, processed, or served.

INDOORS:

HOW TO SPRAY:

- 1 Hold container upright. Do not spray up into air.
- 2 Apply to surfaces only as a spot and crack & crevice treatment.
- 3 Turn sprayer nozzle to "on" position.
- 4 Hold approximately 12 inches from surface to be sprayed.
- 5 Squeeze trigger to spray until surface is slightly moist.

Stink Bugs, Asian Lady Beetles and Boxelder Bugs:

Apply as a spot and crack & crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Exposed food should be covered or removed.

Use of this product is subject to the use precautions and limitations imposed by the label affixed to the container. Read full label before applying.

OUTDOORS:

HOW TO SPRAY:

- 1 Point sprayer away from face.
- 2 Hold sprayer on a slight downward angle, approximately 12 inches from surface to be sprayed.
- 3 Spray with wind if breeze is blowing.
- 4 Do not contaminate fish ponds or apply directly to water.

Application Restrictions for Outdoor Use

Do not water the treated area to the point of run-off. Do not make applications during rain. All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses: (1) Treatment to soil or vegetation around structures; (2) Applications to building foundations, up to a maximum height of 3 feet. Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors, and eaves) are limited to spot and crack-and-crevice applications only.

PESTS ON OUTSIDE SURFACES OF BUILDINGS:

For control of building infestation from **Stink Bugs, Asian Lady Beetles and Crickets:** Spray foundation of building where insects are active and may find entrance up to a height of 2 to 3 feet. Apply to outside surfaces of buildings where insects tend to congregate. Spray areas include (but are not limited to) screens, window frames, eaves, porches, patios, garages and refuse dumps.

Ants:

Spray freely around ant trails and hills. Spray around nests hidden under steps, brickwork, concrete, etc. Break apart accessible nests and spray freely on and around debris.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

STORAGE: Store in a cool, dry area away from children. Protect from freezing. Store above 32 degrees F. If freezing occurs, allow product to thaw and shake well before using. Some product separation may occur on freezing which is reversible on shaking. Freezing does not adversely affect product performance.

PESTICIDE DISPOSAL AND CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. Use product until container is empty. **If empty:** Offer for recycling if available or place in trash. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
