The data shall be retained in personal form for the duration of the business relationship and, once terminated, during the term applicable by law or regulations to which we are subject for the retention of the specific data. A legal retention period of up to 10 y ears applies under tax law, applicable financial regulatory requirements, and to fulfil anti-money laundering requirements. We may keep y our data for longer than 10 y ears where required for legal or regulatory reasons. Where we process your data based on y our consent, we may retain relevant data until your consent is withdrawn.
