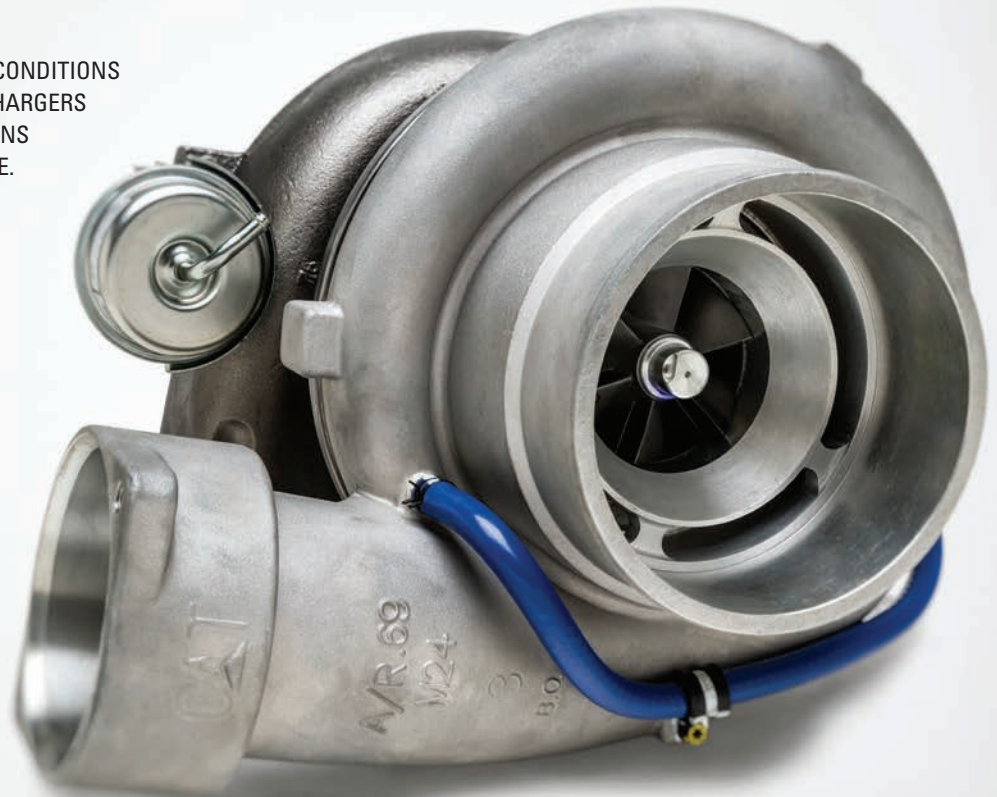

- » Replacement of engine oil, coolant and filters if contaminated during a failure of a covered component

FLEXIBLE CORE ACCEPTANCE CRITERIA

Our core acceptance criteria ensure you get maximum value for your core. We use simple, visual inspections that don't require special tools or disassembly. This allows us to provide an immediate decision on core condition and credit, so you don't have to wait for—or guess about—repair costs.

RECEIVE FULL CORE CREDIT IF:

- » Compressor or turbine wheel is damaged or not rotating
- » Shaft is broken
- » Housing is cracked due to normal operation
- » Turbine housing divider is burnt out
- » There is minor damage to the housing or flange—nicks, chips, cracks, grinder/cut-off wheel damage, hammer marks, corrosion, excessive rust or chisel marks
- » The returning core must be an acceptable Caterpillar part number
