Type and origin of data Which data do we collect from you and from which sources?	The categories of data which we process in order to process a credit application and administer any related finance contract include: Contact details (e.g., name, address, email address, telephone number, digital signature, date and place of birth, proof of identity documents such as Aadhar number, PAN number etc., credit and financial information necessary to assessing a credit application (including credit history and credit agency scoring, details of personal assets), information regarding your existing financing with us, bank account information, tax documentation and proof of company ownership. We do not process any other sensitive categories of personal data. We process data obtained from both (i) direct sources, when you complete our forms or other documents as part of our credit application process or when you use our website; and (ii) indirectly from third party sources including from Caterpillar dealers, external credit or commercial information agencies, market research and the internet.
Primary Processing Purposes How do we use your data?	 To execute and administer finance contracts.
