Completed inspection details are easily retrieved from the streamlined web portal for follow up and opportunity management.

Cat Inspect Mobile Release 4.3.9 (July 8, 2021)

1. "Site Location" field added as part of the QR Code Generation

The person creating the QR code can now enter the Site Location to the QR code, this option is best used for stationary assets or Site Identification. For example, this might be a Dealer Shop/Branch, the location of an Engine Generator Set, or a customer site. When the QR code is scanned as part of an inspection in Cat Inspect, the Site Information will be read into the form automatically.



The number of images added to a question in Cat Inspect App is now included in the User Interface. Previously a User would have to scroll down the window and count the number of images manually. The updated UI allows users to quickly see how many images have been added to a question from within the question details page.

1. Full Screen Mode when using the Create Forms Function

A user can now select Full Screen Mode when creating forms by clicking icon in the top right corner of the Create Form screen. This will assist the form author in creating forms more efficiently.

2. **Inspection preview** now includes **additional question details** including help content, dynamic questions, and question attributes.

This addition detail gives full question visibility to the viewer in the preview screen and does not require the inspection template to be modified to see all the relevant information. Help Content can be added to a question in the form of text, .pdf file or image. This content is designed to assist the inspector with how to rate the question or what to look for in terms of damage or issues. A dynamic question is a question that allows the inspector to repeat the same question as many times as needed. This feature can be added by the form author. Question attributes are like sub-questions and were added enable more flexibility when forms are create allowing the user to capture addition information that supports the top-level question.
