NEW FEATURES

September 2022:

- **Addition of Planned Maintenance Outage & Maintenance Window Notifications**
 - Users will be notified via a Blue Banner Message when an upcoming maintenance window or outage is taking place

June 2022:

- **Manual SMU Updates added to “Service Meter History”**
 - SMU history will include a mix of asset reported & manually entered values
 - Accessible via Asset Details – Overview page

April 2022:

- **Add “3rd Party API Integrations Tool” Link**
 - The “Administration” drop down tab exposes a new link that navigates a user to a new window for a new Cat Harvester Feed configuration page - managed in the Digital Market Place, a 3rd party API integration page.
 - The new link is labeled: **“API Integrator Tool”**
 - The link is exposed only to these user types in MCC:
 1. Validated_Customer **Admins**
 2. Dealer **Admins**
 3. Employee **Admins**

January 2022:

- **New Enterprise page for user “Sign-Up”**
 - My.Cat.Com has a new “Sign-Up” that provides a consistent experience for users across all Cat@ applications.
 - In addition to the new “Sign-Up” page, email verification, State/Province and Zip/Postal fields are now required.
- **Add “No Thanks” Button to Cookie Acceptance Banner**
 - Beneath the current text in the Cookie Acceptance banner, the following text has been added: **“By clicking ‘Agree’, you are agreeing to our use of functional, performance and targeting cookies.”**
 - A “No Thanks” button has been added to the left of the “I Agree” option in the Cookie Statement banner that displays on the MCC page when a user first accesses the site.
 - Clicking the “No Thanks” button writes to the same cookie as the “I Agree” option – but with “rejected”, instead of “accepted”.
 - It then suppresses the banner, and blocks the collection of Google Analytics.
- **Add Excel Download for “My Activity: Tasks” & “Asset Details: Tasks” pages**
 - A download icon has been added for downloading an Excel document of the information on the “My Activity: Tasks” and “Asset Details: Tasks” pages.
 - The download icon on the “My Activity: Tasks” page displays to the left of the “Search” field at the top of the page.
 - All of the “Task” information from the “My Activity: Tasks” page displays in separate columns within the Excel sheet. The columns include the following:
 1. Task
 2. Assigned To

3. Created By
 4. Rating
 5. Due Date
 6. Asset
 7. Notes
- The “Task” data returned on the users “My Activity: Tasks” page displays in rows beneath each column.
 - The download icon on the “Asset Details: Tasks” page displays to the left of the “Search” field within the section beneath the asset dashboard.
 - All of the “Task” information from the “My Activity: Tasks” page displays in separate columns within the Excel sheet. The columns include the following:
 1. Task
 2. Assigned To
 3. Created By
 4. Rating
 5. Due Date
 6. Notes
 - The “Task” data returned on the users “Asset Details: Tasks” page display in rows beneath each column.

November 2021:

- **Maintenance – Post-Rationalization on Completed Services**
 - If the PMM API returns that an asset is rationalizable, and has not yet been rationalized - then the user can rationalize the service level occurrence.
 - On the “Assets: Maintenance” page, a new option has been added under the “Actions” drop-down for the most recently completed service level occurrence that can be rationalized – but has not yet been rationalized. The new option displays at the top of the list of options. This new option is displayed as “Rationalize”.
 - If the service level occurrence can be rationalized, but has not yet been rationalized, then a “circle with a checkmark” icon displays to the right of the “Completed” status tile.
 - This new icon displays to the right of the “memo” icon that displays to show that there are completion notes for the service level occurrence.
 - Hovering over the “circle with a checkmark” icon causes a tool-tip to display that reads as follows: “Not yet rationalized. Click [here](#) to rationalize.”
 - Selecting the “Rationalize” option for the “Actions” drop-down, or clicking the link in the icon hover-over takes the user to the full-page “Schedule Adjustment” modal for the service level occurrence.
 - From the “Schedule Adjustment” modal, the user can select from the rationalization options available.
 - On the “Asset Details: Maintenance” page, the “Rationalize” option has been added to the “Actions” drop-down menu – if the service level occurrence is rationalizable, but it has not yet been rationalized.
 - As with the “Assets: Maintenance” page, those service level occurrences that are displayed on the “Asset Details: Maintenance” page – and can still be rationalized – display with a “circle with a checkmark” icon to the right of the “Completed” status tile.
 - The “circle with a checkmark” icon displays with a tool-tip upon hover (just like on the “Assets: Maintenance” page), with the same text: “Not yet rationalized. Click [here](#) to rationalize.”

- As with the “Assets: Maintenance” page, selecting the “Rationalize” option for the “Actions” drop-down, or clicking the link in the icon hover-over on the “Asset Details: Maintenance” page takes the user to the full-page “Schedule Adjustment” modal for the service level occurrence.
- On the fleet level “Overview” page, a user can filter the “Maintenance” portlet to show only the “Completed” services. Within this portlet, if the most recently completed service is rationalizable, and has not yet been rationalized – then the “circle with a checkmark” icon displays to the right of the “Completed” status tile. Clicking the icon from the “Maintenance” portlet takes the user to the “Asset Details: Maintenance” page – where they can access the “Actions” menu to rationalize as desired.
- On the “Asset Details: Overview (Dashboard tab)” page, there is a “Maintenance” portlet. If the asset has a “Completed” service level occurrence within the selected timeframe AND the completed service level can be rationalized, but has not yet been rationalized – THEN a “circle with a checkmark” icon displays to the right of the “Completed” status tile.
- Clicking the icon from this “Maintenance” portlet takes the user to the “Asset Details: Maintenance” page – where they can access the “Actions” menu to rationalize as desired.

October 2021:

- **Pass Asset Coordinates into Google Maps for Driving Directions**

- A “Get Directions” button/link has been added to the “Asset Location” modal.
- The “Get Directions” button is displayed in the upper left corner of the modal – and is a yellow/primary action button.
- Clicking the “Get Directions” button opens Google Maps in another tab.
- The asset location is passed to Google Maps from the “Asset Location” modal – and displays in the location field within the Google Maps page.
- Google Maps shows the location (latitude/longitude) that was passed, with a map pin.
- There is a “Directions” icon that is displayed on the Google Maps page – that when clicked shifts the Google Maps page to a state where the final destination field is pre-filled with the asset location.
- The user is able to enter the starting point into the appropriate field, and get driving directions returned.

February 2021:

- **Maintenance – Update to V3 API to All “Enable/Disable” of VL Assets & Disable “Track” Toggle for VL Assets**

- MCC has been updated to use V3 for the PM API, so that VisionLink asset tracking can be enabled/disabled – using the “Enabled/Disabled” toggle in the “Maintenance Settings” modal.
- The “Enabled/Disabled” toggle no longer displays as “grayed out” (inactive) for VL, but displays the same as it does for all other assets.
- Since the “Enabled/Disabled” toggle is now functional for VL assets, there is no tool-tip that displays upon hover.
- On the “Edit Maintenance Settings” page, the “Track” toggle displays as inactive for VisionLink assets.
- Hovering over the inactive “Track” toggle causes a tool-tip to display. The text within the tooltip reads: “VisionLink subscribed assets cannot be enabled or disabled in My.Cat.Com.”

November 2020:

- **Account Provisioning - My.Cat.com “Welcome” Email Updates**

- The My.Cat.com customer “Welcome” email has been updated to read as follows:

Thank you for registering with My.Cat.com.

Your username is: (username)

Your Cat dealer(s) has received your request to link you to the correct account(s) or have a new account created.

Your Caterpillar account is the single account that you can use to log in to select Cat® applications including:

October 2020:

- **Account Provisioning – Add Legal Footer Text to All My.Cat.com Emails**

- Legal footer text has been added to the bottom of **ALL** emails sent out by My.Cat.com. The text reads as follows:

“© 2020 Caterpillar. All Rights Reserved. CAT, CATERPILLAR, LET'S DO THE WORK, their respective logos, "Caterpillar Corporate Yellow", the "Power Edge" and Cat "Modern Hex" trade dress as well as corporate and product identity used herein, are trademarks of Caterpillar and may not be used without permission.”

- The footer section is light gray color, with the text displayed a darker gray text.

- **New Email to Existing Users Added to MCC**

- A new “Welcome” email is sent to existing users that are added as users for a specific UCID in My.Cat.com. This email is sent to the existing users that have never logged in to MCC.

- The text of the email should read:

You have been granted access to My.Cat.com by <Dealer Admin/Customer Admin requestor’s name – First Name (Preferred) Last Name>.

Your username is: <username>

- Beneath the “username” text, there is a yellow button with the text “Sign in to My.Cat.com”. Clicking this button takes the user to My.Cat.com launch page – where they are able to enter their username to access My.Cat.com.
- Beneath the “Sign in to My.Cat.com” button, the email displays the same text as in the standard “Welcome” email – which provides the email recipient with brief description of the other Cat applications that they can access with their account.
- The text reads as follows:

Your Caterpillar account is the single account that you can use to log in to select Cat® applications including:

- **My.Cat.com:** Manage your equipment. Track maintenance activities, view invoices, schedule operations, and more.
- **Cat App:** Manage your equipment. A companion app to [My.Cat.com](#), where you can manage your equipment on the go from your iOS or Android mobile devices.
- **Cat.com:** Explore products. Set site-wide preferences, set a preferred dealer, and streamline materials requests.
- **Parts.Cat.com:** Buy online. Experience a fast checkout process, saved order history, saved lists, and more.

- The very bottom of the email includes the standard MCC email legal footer.

September 2020:

- **“Invite New User” flow – Send New “My.Cat.Com/Cat App User Invitation Accepted” Email**
 - When a user has accepted a MCC “Invite” from an email invitation that they received, the dealer(s) that the user is now associated with is sent a new email. The Dealers Admins are notified that the new user will need to be granted additional access to some applications – if desired.
 - If the user is associated to multiple dealers, a separate email is sent to each Dealer Admin.
 - The email is sent to the email address that is listed on the "Dealership Configuration" screen.

August 2020:

- **Cancel Validation request process – Dealer provided cancellation reason, and email sent to user**
 - On the “Administration: Dealership Tasks” page, a user can choose to cancel a “Validate Customer User” dealership task from the “Actions” drop-down (“Set Cancelled”). Selecting this option causes the “Cancel Validation Request” modal to display.
 - Submitting this modal triggers the system to send the “Account Validation Cancelled” email.
 - Hovering over the “CANCELLED” tile opens a tool-tip that displays the “Cancellation Reason” – with the text of the “Reason for Cancellation” entered in the modal. In addition, there is a “Cancelled By” label – followed by the name of the person who cancelled the validation request.
- **“Registration Report” cancellation email to users (with Dealer reason included)**
 - Administration users can cancel an Account Validation Request that is still pending, by selecting this option on the “Registration Report”. The owner of the account that has had the validation cancelled will receive an email detailing the name of the person who cancelled the request, as well as the reason given for the cancellation.
- **Expand/Collapse the left-navigation on the “Asset Details” page**
 - The sidebar portion of the Asset Details page can expand and collapse as shown in the images below.
 - When collapsed, the side bar text is removed leaving only a set of symbols.
 - Hovering over a symbol shows the symbol’s full name in a tool-tip.
 - If a sidebar item has multiple selections below it like Health & Maintenance, the user can click on the icon and a sub-menu will pop out to the side as shown in the image above, with the various selections in that sub-menu.



July 2020:

- Ability to complete maintenance occurrence outside of the current schedule
 - Users are able to mark upcoming “Independent Interval” or “Major Component” interval maintenance tasks as “Complete”.
 - Users are able to “View Job Operations and Buy Parts” for the maintenance tasks listed in the “Services Outside of Schedule” modal.
- Add a “Customer Value Agreement” icon for assets with a CVA
 - A new Customer Value Agreement icon has been added to several places on MCC pages.
 - The Customer Value Agreement icon has been added to assets that display on the following pages (for both desktop and mobile views);
 1. **Asset Details**
 - The “Ownership” section has been renamed to “COVERAGE”.
 - Beneath the “COVERAGE” label, the “ownership” and “CVA” icons are stacked. The “ownership” icon is stacked on top, with the icon and text as it is today under the “Ownership” label.
 - The “CVA” icon is under the “ownership” icon, with the text “CVA” to the right of the new yellow icon.
 2. **Assets: List (Grid view)**
 - The new yellow “CVA” icon has been added to the row of icons displayed to the right of the Asset ID data.
 - The “CVA” icon is in-line with the “ownership” icon, and the “connection” icon.
 - The “Connection” icon is displayed first, then the “CVA” icon, and then the “Ownership” icon.
 3. **Assets: List (Map view) – both on the map, and on the right side in the list**
 - The new yellow “CVA” icon has been added to the row of icons displayed to the right of the Asset ID data within the pop-up modal for the map pin. The “CVA” icon is in-line with the “ownership” icon, and the “connection” icon.
 - The new yellow “CVA” icon has been added to the row of icons displayed to the right of the Asset ID data shown in the list of assets to the right of the map. The “CVA” icon is in-line with the “ownership” icon, and the “connection” icon.
 - The “Connection” icon should be displayed first, then the “CVA” icon, and then the “Ownership” icon.

June 2020:

- “Invite” flow – display message to user if email address has an open invitation
 - When sending a My.Cat.Com invitation to a potential new user, the user must enter an email address. If the email address that is entered already has an open invitation, then an error message will display letting the user know that an invitation already exists – and the system will not allow them to submit another invitation to the same address.

May 2020:

- New “Invite New User” flow
 - “Invite New User” to My.Cat.Com: From the “Administration > Manage Customer Users” screen, new customer users can be invited to create an online account for My.Cat.com and Cat App. This replaces the current “Add New User” button and provides a simple, updated flow to give customers validated access. Note: Dealer Admins and Customer Admins are the only ones who have access to this feature. Clicking the “Invite New Users” button opens an “Invite New User” modal – where the email address(es) for the invitation(s) can be entered, as well as the user role for those being invited, the capabilities they will have, and the DCNs they will be able to access.

- “Invitations” tab on “Manage Customer Users”: An “Invitations” tab displays on the “Manage Customer Users” page, where all of the invitations that have been sent are listed. The invitations remain on this tab until the customer takes action, or for 90 days. Once the customer takes action by creating an account their information will be visible on the “Customer Users” tab. Each invitation can be edited, cancelled, or resent from the “Actions” drop-down.
- Emails sent from “Invite New User” flow: If an invitation is sent to an email address that has no CWS ID tied to it, then the email that is sent is to “Register for My.Cat.Com”. The email contains a link to the “Create your Cat account” page – where the email address is pre-populated with the email address to which the invitation email was sent. Once on the “Create your Cat account” page, the user will be able to complete the process of registering for My.Cat.Com by setting their username and setting a password. If the email address entered for inviting a new My.Cat.Com user is one that is already tied to an existing CWS ID, then the email that is sent will include the existing usernames for the entered email, and provide a link for the user to “Sign in to My.Cat.Com” – rather than creating a completely new account. If the user has any problems remembering the password associated to the usernames included in the invitation email, they can get help from the “Forgot Password” link on the My.Cat.Com launch page.
- Invite New User – “Administrator Initiated Accounts” Report: Admin Users can access a new “Administrator Initiated Accounts” report as an option under “Administration”, to help track the new customers added from the user invitations that are being generated. From this report, the Admin User can see when the new customer account was created, and who created the customer’s account.
- Updates to My.Cat.Com password requirements
 - The requirements for creating a password for My.Cat.Com have been updated for customers to only require 3 of the 4 items (lower case letter, upper case letter, number, or special character), instead of all four. The password requirements for dealer and employee users are not changing, they will still require at least 12 characters, and all 4 of the items.
- Two new “Dealership Tasks” reports added
 - There are two new “Dealership Tasks” reports that combine similar dealer task types into a single report to make it easier for a user to gain the information that they need. “All Service Requests” - Combines “Schedule General Service Request”, “Schedule Fault Code Service”, “Schedule GPS Rollover Service”, “Schedule Maintenance Service”, “Schedule Inspection Service” and “Schedule SOS Service”. “All Subscription Requests” - Combines “Upgrade Telematics Subscription” and “Create Telematics Subscription”

May 2022:

- **All Available DCNs default selected in all “Add User(s)” situations**



- When an Admin user tries to add a user, the available DCNs that are listed at the bottom of the modal (in the “Accounts” section) are all selected by default.

April 2022:

- **Maintenance – Show Consistent Messaging for Manual Maintenance SMU**
 - As an end user, when I attempt to update the Service Meter for an asset that has a Manual Maintenance subscription, and the SMU value to be updated cannot be less than the last reset SMU value, display the PMM error message being returned by PM.
 - In the "Edit Service Meter" modal MCC is now using consistent messages that are more specific as to why an update wasn't allowed.
- **Add Street Address to the Dealer Branch Address in Dealer Selection Map View**
 - The address displayed for each of the Dealer branch locations returned on the “Dealer Selection” page include the street address as part of the address.

March 2022:

- **CVA “Expiration Scenario” column added to “Assets: Agreements” and “Asset Details – Agreements”**
 - The “Contract #” column is displayed on the “CVA” tab – when it’s Empty/Blank a hyphen (-) is displayed.
 - An "Expiration Scenario" column has been added to both the “Assets: Assignments” and “Asset Details – Agreements tab” pages
 - The new “Expiration Scenario” column is displayed between the “Dealer” and “Start Date” columns.

Maintenance – Display “Hours” input fields for “Expected Runtime” when “serviceMeter” value is zero

- The MCC UI has been updated to always show the “Hours” SMU component (input fields) in the “Expected weekly runtime” section – even if we get nothing back (0.0) from the PMM Service.
- When the PMM Service returns zero for “serviceMeter”, the default values in the input fields display.

- The other SMU component input fields only display in the “Expected weekly runtime” section if we get a non-zero value for that SMU component.
- The "Service Meter" value in the top portion of the modal (under the asset ID information) is displayed in all cases also - even though the value returned (and displayed) is zero.

February 2022:

- **"Device Type" added as a new global "Filter" for Fleet pages**
 - A “Device Type” option has been added to the global “Filters”.
 - Within the “Edit Filters” modal, a “Device Type” drop-down field has been added.
 - The new "Device Type" drop-down field is placed after "Make", and before "Subscription".
 - The items in the drop-down includes “All” (default selected), and “No Device” – so that users can filter to get only those assets which have no telematics device.
 - The remaining items in the drop-down list include each of the different telematics device types that are present on any of the assets in the fleet list.
 - If a “Filter” is selected from the “Device Type” drop-down, then the “Filters” button on the screen displays a “1” in a yellow circle – to represent a filter has been applied. If additional filters are applied, then the number displayed increases to show the total number of filter types that are being applied to the fleet list.
 - In addition to the display for filter types, there are filter “chips” displayed next to the page title. Each of the specific filter options selected are displayed, so if multiple “Device Types” are chosen, each is shown with a separate “chip”.
 - The filter “chips” each have an “X” within it, so that user can remove that specific filter.
 - Any filters that are applied to a fleet level page carry over to all of the other fleet level pages.
- **Mandatory Fields on Customer Registration (State/Province, Postal/Zip Code)**
 - These new mandatory fields are mapped into the “Validate Customer User” email that is sent to the selected Dealer accounts.
 - The mandatory “State/Province” and “Postal/Zip Code” fields have been added to the information displayed in the “Validate Customer User” email under “CONTACT INFORMATION”.
 - “State/Province” has been added under the “Country” field.
 - “Postal/Zip Code” has been added under the “State/Province” field.
- **“Validate User” – “Role” Pre-Selection removed & Default to “Admin” if Company has no Administrator**
 - Within the “Validate User” modal, the “Role” drop-down displays without an option pre-selected.
 - The “Role” drop-down field displays with the text “Please Select” – and replaces that text with the selected user role once it is chosen.

 - The “Sorry, you do not have access to this page.” page also includes a yellow “Log in as a different user” button.
 - When the user clicks the "Log in as a different user" button, they are taken to the My.Cat.com landing page - where they can enter a different username and password.
- **Add Dealer Name and DCN to Subscription Tool-Tip**



 - A new service has been created to return the Safety Service Letter text to be displayed in the modal.
 - Removed Safety Service Letter # visibility to customer end-users.
- **Updates to the display of “Assets: Health” ratings**
 - The component rating severity to overall asset “Rating” mapping for the “Asset Details” dashboard and fleet level list has been updated to match the table below:

- The “Health” portlet on the “Overview” page now displays with three sub-sections (“Fault Codes”, “SOS”, and “Inspection Results”) – each section divided by a light grey line.





- The title of each section – “Fault Codes”, “SOS”, and “Inspection Results” – is linked text, that when clicked takes the user to the “Assets: Health” page, with the specified sub-section tab displayed.
 - Clicking the “Fault Codes” text takes the user to the “Assets: Health” page with the “Fault Codes” tab selected.
 - Clicking the “SOS” text takes the user to the “Assets: Health” page with the “SOS” tab selected.
 - Clicking the “Inspection Results” text takes the user to the “Assets: Health” page with the “Inspections” tab selected.
- Underneath each sub-section title, there are further categories/statuses displayed – with the number of assets in each status displayed in front of the status tile.

Fault Codes

The “Fault Codes” section displays counts and tiles for the following statuses:

1. **“High” (red)**
Clicking on the “High” tile takes the user to the “Assets: Health” page, with the “Fault Codes” tab selected – and filter applied to the page to only show those assets that are in the “High” status.
2. **“Medium” (yellow)**
Clicking on the “Medium” tile takes the user to the “Assets: Health” page, with the “Fault Codes” tab selected – and filter applied to the page to only show those assets that are in the “Medium” status.
3. **“Low” (blue)**
Clicking on the “Low” tile takes the user to the “Assets: Health” page, with the “Fault Codes” tab selected – and filter applied to the page to only show those assets that are in the “Low” status.

SOS

The “SOS” section displays counts and tiles for the following statuses:

1. **“Action Required” (red)**
Clicking on the “Action Required” tile takes the user to the “Assets: Health” page, with the “SOS” tab selected – and filter applied to the page to only show those assets that are in the “Action Required” status.
2. **“Monitor” (yellow)**
Clicking on the “Monitor” tile takes the user to the “Assets: Health” page, with the “SOS” tab selected – and filter applied to the page to only show those assets that are in the “Monitor” status.
3. **“Normal” (green)**
Clicking on the “Normal” tile takes the user to the “Assets: Health” page, with the “SOS” tab selected – and filter applied to the page to only show those assets that are in the “Normal” status.

Inspection Results

The “Inspection Results” section displays counts and tiles for the following statuses:

1. **“Red” (red)**
Clicking on the “Red” tile takes the user to the “Assets: Health” page, with the “Inspections” tab selected – and filter applied to the page to only show those assets that are in the “Red” status.
2. **“Yellow” (yellow)**
Clicking on the “Yellow” tile takes the user to the “Assets: Health” page, with the “Inspections” tab selected – and filter applied to the page to only show those assets that are in the “Yellow” status.
3. **“Green” (green)**
Clicking on the “Green” tile takes the user to the “Assets: Health” page, with the “Inspections” tab selected – and filter applied to the page to only show those assets that are in the “Green” status.

At the bottom of the “Health” portlet, there is a “See all” link in the lower left corner. Clicking on the “See all” link takes the user to the “Assets: Health” page – with no filters applied

August 2021

- **Tool-tips added for Maintenance “Utilization” options**
 - Within the “Edit Maintenance Settings” modal, in the “Utilization Options” section – hover-over tool-tips have been added to the “90 day” and “7 day” options. When the user hovers their cursor over the “90 day option” text, or the “7 day option” text - the following tool-tips (with text) display.
 - **90 day option:** “Longer average calculation periods decrease the variability and provides a more consistent calculation.”

- On the “Registration Report” (“User Report” tab), when there is a cancelled validation request listed (cancelled validation request will be denoted with a grey “X” icon) – hovering over the icon opens a tool-tip.
- The tool-tip should display the following information about the validation request cancellation:
 - Cancellation Reason
 - Cancelled By
 - Cancelled Date

July 2021

- **Maintenance - Utilization Settings - New 7 day “Average Runtime” option**
 - The existing “Average runtime based on telematics utilization history (RECOMMENDED)” option has been renamed, and the following has been established as the default option: **“90 day average runtime based on telematics utilization history (RECOMMENDED)”**
 - A new option has been added (under the “90 days average runtime based on telematics utilization history (RECOMMENDED)” option) – that displays as follows: **“7 day average runtime based on telematics utilization history”**
 - The average historical Runtime data points/text we're currently showing within the grey box has been removed.

- **Add “Odometer” tabs to Fleet and Asset Utilization pages**

Asset Details Utilization Page

A third tab has been added to the “Asset Details – Utilization” page, to be displayed to the right of the existing “Hours” and “Fuel” tabs. The new tab is labeled “Odometer”.

The table on the “Odometer” tab has three columns displayed:

1. **Date** – this column displays the date the odometer was collected
2. **Odometer** – this column displays the odometer value (“totalDistanceTraveled”) on the specified date.
3. **Daily Travel** – this column displays the change in the odometer value from the previous date.

The unit of measure that is displayed (“Miles” v. “Kilometers”) is determined by the user’s Unit of Measure preference.

Above the table, there is a graph displayed - the following graph data/selectors are shown:

- **Metric** – this always displays the text “Odometer” when on this tab
- **View** – this is a drop-down selector that allows the user to select to view the graph as either a “Bar chart” or a “Line chart”
- **Unit** – this displays the unit of measure that is being used to display the odometer date (this is based on the user’s unit of measure preference, and is either “Miles” or “Kilometers”).

Fleet List Utilization Page

An “Odometer” tab has been added to the “Assets: Utilization” page, with the new tab displayed between the existing “Fuel” and “Benchmarking” tabs.

The table on the “Odometer” tab has three columns displayed:

1. **Asset** – this column displays the asset image, as well as the Asset ID/Serial Number/Make & Model information for the specific asset
2. **Total Travel** – this column displays the latest total distance traveled for the asset, based on the date selected

The unit of measure that is displayed (“Miles” v. “Kilometers”) is determined by the user’s Unit of Measure preference.

Above the table, there is a graph displayed – with the following graph data/selectors shown:

- **Metric** – this always displays the text “Total Travel” when on this tab
 - **View** – this is a drop-down selector that allows the user to select to view the graph as either a “Bar chart” or a “Line chart”
 - **Unit** – this displays the unit of measure that is being used to display the odometer date (this is based on the user’s unit of measure preference, and is either “Miles” or “Kilometers”).
-
- **Add Additional SMU Value for Assets – “Odometer”**
 - The SMU data that is returned to MCC includes information specific to Service Meter values measured in “Hours”, a separate reading for “Odometer”, and finally a “generic” SMU value.
 - Connected assets always have an “Hours” based SMU value, but could also return additional SMU values – like “Odometer”. In instances where both “Hours” and “Odometer” are returned, we display both measures. If only one is returned, then only that single SMU value is displayed.
 - Unvalidated assets should only return a single SMU value – either “Hours” or “Odometer”, in most cases. Therefore, there is only be a single SMU value displayed.
 - If an asset has neither an “Hours” SMU value, nor an “Odometer” SMU value returned – then the “generic” SMU value is displayed. This value will likely be either a “Fuel” based SMU value (“Gallons”/“Liters”), or “Kilowatt Hours”.
 - For connected assets that return both an “Hours” and an “Odometer” SMU value, the odometer value is displayed under the “Hours” SMU value in the “Asset Details” dashboard.
 - The “Service Meter” label displays with a “pencil” icon to the right of the label, that when clicked opens the “Edit Asset” modal – allowing the user to update the service meter value(s) manually.
 - For both the “Hours” SMU value, and the “Odometer” SMU value, the numeric value includes the “unit of measure” label. The “Odometer” SMU value label will be either “Miles” or “Kilometers” (based on the users selected user preference).
 - Beneath the SMU value, there is the “Last Update”. After the “Last Update” text, we display the date and timestamp associated to the data point.

- If the screen resolution is smaller, some of the items in the “Asset Details” dashboard wraps into a second row. When this occurs, the “Odometer” SMU value is not one of the items that “wraps” – but instead, the odometer SMU value remains anchored beneath the “Hours” SMU value.
 - When viewing the “Asset Details” page on a mobile device, an asset that returns an “Odometer” SMU value displays the odometer SMU value to the right of the “Hours” SMU value.
 - When viewing assets on the “Assets: List” page (only on the “**Grid**” view) – assets also display “Odometer” SMU values if both “Hours” and “Odometer” are returned.
 - Those assets with an “Odometer” SMU value returned display the odometer information between the current “Service Meter” (Hours) information, and the asset “Location” data.
 - The “Odometer” data displays with the label – “Odometer:”, with the actual numeric value and unit of measure label displayed to the right of this label.
 - Just as with the “Service Meter” display, the “Odometer” data displays with the “Last Update:” information in the row beneath the odometer value. Just as with the display on “Asset Details” pages, the “Last Update” information includes the date and timestamp for the latest data update.
 - The Odometer data is displayed based on the user’s preference - SI units or US standard:
 - SI Units selection = Kilometers
 - US Standard selection = Miles
- **Add “Odometer” and “Location” to Utilization XLS Downloads**

1. On the “Asset Details – Utilization” page - for XLS downloaded files:

- (a.) A new column for daily (last known) “**Location**” (like on Location portlet) has been added - inserted after the “Service Meter UOM” column.
- (b.) A new column for a daily “**Odometer**” value has been added (inserted after the new “Location” column).
- (c.) A new column for “**Odometer UOM**” has been added (inserted after the “Odometer” value column).

2. On the Fleet “Utilization” page - for XLS downloaded files:

- (a.) A new column for “**Total Travel**” has been added - inserted before the “Work Fuel Burn” column.

- **“Assets: Health” (Inspections) - Add “View Executive Summary PDF” Option to “Actions” drop-down**

- On the “Assets: Health” page, under the “Inspections” tab – the “Actions” drop-down for each asset should display with the following options:

 - 6. "Request Service"
 - 7. "Buy Parts"
- With the new "View Executive Summary PDF" option displayed between "View Actionable PDF" and "Request Service".

June 2021

- **Add "Cancelled Request" Date/ Timestamp in "Registration Report" Excel downloads & "Cancelled Request" state on page**
 - A new "Email Address" column has been added to downloads of the Registration Report. A new "Cancelled Requests" column has been added to downloads of the "Registration Report". The new column is between the existing "Validated" and "Unvalidated Days" columns.
New Cancellation Reason & Cancelled By columns are added after the Cancelled Requests column.
 - The cells in the new "Cancelled Requests" column display the time a request was rejected by an Admin.
 - The time shown includes the date, and a timestamp.
 - A "Cancelled Requests" status has been added within the drop-down on the "Registration Report" page.
 - The "Rejected" column name on the "Dealer Report" tab is updated to read "Cancelled".
 - The "Average Rejected Days" column name on the "Dealer Report" tab is updated to read "Average Cancelled Days".
 - Update the label for "Rejected" on the "Status Chart" tab to read "Cancelled"

- **Update Descriptive Text in "Add Asset" and "Add Multiple Assets" Modals**

- **Account Provisioning – Update White Text on the MCC “Sign Up” Page**
 - On the My.Cat.Com “Sign Up” page (step 1 of the registration flow), the white text that displays on the image has been replaced with the following text:

"One Account. All of Cat.
Your Caterpillar account is the single account you use to log in to select services and applications we offer. Shop online, manage your fleet, go mobile, and more."
 - The “One Account. All of Cat.” text is displayed in a separate line above the other text – and is in bold.
 - The remaining text is not bold, and wraps as needed to fit within the screen space.
- **Account Provisioning – Add “One Account. All of Cat” Text to MCC Sign-In Page**
 - On the MCC Sign-In page, the “Sign-In” portlet has the following text under the Cat logo: “One Account. All of Cat. Sign in using an existing Cat® account.”

Maintenance – Interval “Frequency” Unit of Measure Editable When “One Time Only”

- The “Add Independent Interval” and “Add Major Component Interval” modals have been updated to leave the “Frequency” unit of measure drop-down active when the “Occurs only once” option is selected.

- The “Frequency” numeric input field is inactive when the “Occurs only once” option is selected.
- When the “Occurs only once” option is NOT selected, then both of the “Frequency” input fields (numeric, and unit of measure drop-down) are active.
- When the “Frequency” unit of measure drop-down selection is changed, the unit of measure for the “First Occurrence” field changes to match the same unit of measure.

September 2020:

- **UI: Asset Details: Health & Maintenance: Alerts screen Fault Codes - move Service Meter column**
 - As any user role on the Asset Details: Health & Maintenance: Alerts screen Fault Codes tab:
 - The Service Meter column displays in the main table view before the Actions column.
 - In Desktop view with the browser window in full screen view the expand row triangle icon is not displayed.
 - In Desktop view when the browser width is reduced so that all columns of data do not fit, then columns are moved to the expanded row section. A horizontal scroll bar is not displayed.

Add “Describe Service Needed” text to “Schedule General Service” email

- The “Schedule General Service” email has been updated to include the text entered in the “Describe Service Needed” field of the “General Service Request” modal.
- A new “Service Needed” field has been added to the “SERVICE REQUEST” section of the email. This new field displays beneath the “Preferred Date” and “Service Location” fields.

- **“Asset Details: Utilization” – Show Chart Area with X-Axis and Y-Axis but No Points Plotted**
 - If the data table on the “Asset Details: Utilization” page does not have any data displayed in it (only dates shown) – then still show the chart area, but include the x-axis and y-axis, just with no points plotted.
 - If there is data displayed in the table, then the default view of the page is to display the chart area.

- **VALIDATE USER: Error while validating the Customer User when the Customer is not onboarded**
 - When the dealer tries in to add a customer user under a customer not onboarded under the dealer,
 - The Dealer should be prompted to onboard the customer first
 - Once the customer is onboarded, the delaer should be prompted to onboard the customer user.

August 2020:

- **Dealer “Registration Report” changes**
 - The columns in the table displayed on the “Registration Report – Dealer tab” have been updated. The values for each (excluding “Dealer”), represent a count of items in that “state” for the date range chosen.
 - “Dealer” – this column displays the dealer’s name

- “Total” – this column displays the total count of registrations requests that the dealer has received within the date range selected. This is the total of “Validated” + “Rejected” + “Pending Validation”.
 - “Validated” – this column displays the count of registration requests that have been validated by the dealer within the date range selected.
 - “Rejected” – this column displays the count of registration requests that have been rejected by the dealer within the date range selected.
 - “Pending Validation” – this column displays the count of registration requests that are pending validation (within the date range selected).
 - “Average Validation Days” – this column displays the calculated average number of days it took the dealer to validate a registration request (within the date range selected).
 - “Average Rejection Days” – this column displays the calculated average number of days it took the dealer to reject a registration request (within the date range selected).
 - “Average Pending Validation Days” – this column displays the calculated average number of days that a registration request remained in the “Pending Validation” state (within the date range selected).
 - An information icon is displayed to the right of each of the column heading labels. Hovering over the icon displays a brief explanation for each.
 - The “Status Chart” tab has also been updated to display bar charts for the number of registration requested in the “Validated”, “Rejected”, and “Pending Validation” statuses.
- **New User “Invite” email – provide a contact name and email information**
 - Within the “Register for My.Cat.Com” and “Sign In to My.Cat.Com” emails, the email content beneath the action button has been updated as follows:
 1. The Customer Admin/Dealer Admin requestor’s name is rearranged to display as – First Name (preferred) Last Name.
 2. If a Customer Admin is sending the invitation email, their email address is displayed as the contact within the email text.
 3. If a Dealer Admin is sending the invitation email - they have to choose which email address to display, before submitting the invitation. The designated email address serves as the method by which the invited user can reach out for questions. The Dealer Admin will need to select from the options listed below:
 - a. The Inviter's email address or
 - b. The Dealer branch entered email address under "Access Requests from Customers" - associated to the Dealer Admin performing the request. If there are multiple email addresses that have been provided for the Dealer branch email address, show each of the email addresses - separated by a comma.
 - **Default New Customer “Capabilities” set to match Dealership “Capabilities”**
 - When a Dealer Admin wants to add a new Customer (Company) – the checkboxes under “Capabilities” are default populated to match those for which the Dealership is configured/enabled.
 - **Cat Digital Support phone numbers exposed to users**
 - In the Contact Cat Digital Support modal the introduction text has been updated to: Caterpillar is dedicated to improving your My.Cat.Com experience. Use this form to report any issues you find or enhancements you would like to see or contact us at +1-866-228-2111. We value your feedback.
 - In the Operations: Telematics Invoices portlet Billing Inquiry modal, the introduction text has been updated to: Please use this form to raise any inquiry about your invoice(s) or contact us at +1-866-228-2111. We value your feedback.



July 2020:

- **Add “Interval Type” to PM downloads**
 - A new column, titled “Interval Type”, has been added to the download file generated from “Maintenance” screens.
 - The information in the “Interval Type” column matches the different symbols displayed on the screen.
 - If the icon shown in “Next Service” is a STAR, the interval type in the report should read “Service Level”
 - If the icon shown in “Next Service” is a CIRCLE, the interval type in the report should read “Independent Interval”
 - If the icon shown in “Next Service” is a TRIANGLE, the interval type in the report should read “Backlog”
 - If the icon shown in “Next Service” is a DIAMOND, the interval type in the report should read “Major Component”
 - The color of the icon does not affect the value for “Interval Type” in the export report.
- **Update the “Record Service” modal UI**
 - Within the “Record Service” modal, the placeholder text for the “Type of Service Performed” drop-down field has been updated to read: “Select”.
 - For the “Machine Component Serviced” drop-down field, the placeholder text has been updated to read: “Select”.
 - Only a single set of these input fields are shown on initial view of the modal.
 - If a user tries to submit the “Record Service” modal without first making selections for the “Type of Service Performed” and “Machine Component Serviced” fields – validation error messages display under the fields.
 - Beneath the “Type of Service Performed” and “Machine Component Serviced” input fields, an “Add Another” link has been added – that when clicked adds an additional set of the two input fields.
 - Only one set of the “Type of Service Performed” and “Machine Component Serviced” fields is required, but if the user “adds another” the added fields are also required. The added fields should display with a delete (trash can) icon, so that they can be removed.
- **Update the UI for the “Schedule Service” modals**
 - The “Describe Service Needed” section has been moved higher in the modal, placing it below the “Contact Method” radio button options.
 - The “Service Location” section displays beneath the “Describe Service Needed” input field.
 - Under the “Service Location” label, there is the following text: “Please select where the machine will be located at the time of service. If the Current Asset Location displayed is not accurate, please update it.”
 - On initial display, the two radio buttons display (“Current Asset Location” and “Dealer Location”) – with neither option selected. In this state, the map for the “Current Asset Location” does not display.
 - If the user selects the “Current Asset Location” radio button option, then an input field displays with the current asset location, or a “-” if no location is known. The user can update the current location by typing in this field.
 - Under the input field, a map displays with the current asset location identified by a map pin.
 - If the user selects the “Dealer Location” radio button option, the input field and map under “Current Asset Location” do not display.
 - The text entered in the “Describe Service Needed” field has been added into the email that is sent when the “Schedule General Service” modal is submitted.
 - The input field that displays beneath the “Service Location” section in all of the other “Schedule ..” modals (Fault Codes, SOS, Inspections, and Maintenance) has been removed.



June 2020:

- Addition of Diesel Engine Fluid (DEF) information to “Asset Details”
 - The “Asset Details” page now includes information on both “Fuel Level” and “Diesel Exhaust Fluid Level” – for those asset that report these values.
- Display the values for “Shift All” option within “Schedule Adjustment” modal
 - The “Schedule Adjustment” modal has been updated to display the amount by which the services associated to an asset will be shifted when the user opts to “Shift all services”. This option will now display how much each subsequent service will be shifted from it’s current value.
- Addition of time stamp and time zone information for “Last Reported” data
 - “Service Meter” values, and “Location” data for connected assets will now display with the date the information was last updated, as well as the time of the update. In addition, the time zone for the time being reported will be displayed – so the user can know exactly when the data was updated.
- Increase the number of characters allowed for a step name for maintenance intervals
 - The “Edit” modals for each of different maintenance interval types (“Service Level”, “Independent Interval”, “Major Component”, and “Backlog”) will now have a character limit of 1,000 for each “Step Name” – increased from 100 characters.
- Display of an “alert” icon on “Operations – Rental” page for assets within 5 days of billing cycle
 - On the “Operations – Rental” page, users will see a red alert icon next to the billing cycle date for any assets that have a billing cycle due date within five days of the current date. This will help users easily identify those rental contracts that will soon have a payment coming due.
- Updates to the “Schedule Adjustment” modal for maintenance
 - When a “Service Level” maintenance task is completed, a user is sometimes required to rationalize the service tasks that come after it. If rationalization is needed, the “Schedule Adjustment” modal will be displayed. The size of this modal has been enlarged to allow the user to see both their options, and the timeline preview of services at the same time. Those options that require additional inputs from the user will only show the input fields when those radio buttons are selected. This allows the user to more easily see the timeline preview without having to scroll.
- “Warranty” information visibility on “Asset Details”
 - The “Warranties” tab will be hidden from any Dealer who is not connected to Fast Iron – so they do not see empty tabs. When the “Warranty” settings for an account are turned on, the “Warranties” card and the “Warranties” selector in the “Asset Details: Overview” configuration menu are displayed - allowing the user to display or not display the “Warranties” card. When the “Warranty” settings for an account are turned off, the “Warranties” selector in the “Asset Details: Overview” configuration menu are not shown (i.e., no option to select/show the “Warranties” card)
- Addition of status flag information to maintenance downloads
 - Users are able to associate a status flag to a maintenance task, but until now the status flag information has not been included in the download generated on the “Assets: Maintenance” or “Asset Details – Maintenance” pages. Two new columns have been added to the download – one for the “Status Flag Name” and another for the name of the person who modified the status flag (“Status Flag Modified By”). These two columns have been added between the “Completed Date” and “Location” columns that were already included in the download.
- Addition of “View Fleet” link to “Manage Customer” page
 - The “Administration: Manage Customers” page now provides a “View Fleet” link for each of the customers listed. Clicking the “View Fleet” link takes the user to the “Assets: List” page for that specific customer.
- Addition of filters to the “Registration Report”



- The “Registration Report” now has a new page filter option – “Source”. Under the new “Source” filter, the user can select the source of the registration information to show only those registrations from My.Cat.Com, Cat App, Cat Inspect, or from an External source. They can also view the data from all of the sources combined. This will help Admin users keep track of where most of the new registrations are coming from.

May 2020:

- Updates to screen “Filters” and “Manage Groups”
 - Persistent screen “Filters” and “Manage Groups” access: The filters applied on one page are now persistent across other My.Cat.Com pages. In addition, all existing “Groups” will be available in the “Edit Filters” modal on all pages that allow filtering. In addition, through a “Manage Groups” link within the “Edit Filters” modal – users can now easily create/edit groups on any page with filters, not just the “Assets: List” page.
 - Updated “Manage Groups” page: By clicking the “Manage Groups” link within the “Edit Filters” modal, or the button on the “Assets: List” page – a user can access the “Manage Groups” screen to create a new group, or edit an existing group. Users can select from a list of “Available Assets” to add to their group, with those that have been selected listed on the right side of the screen.
 - Applied “Filters” Displayed Next to Page Title: Any filters that are currently applied to a page will be displayed separately next to the page title. Users can remove a filter by clicking the “X” in the tile next to the page title, or within the “Edit Filters” modal. The “Filters” button on the page will show the total number filter categories that current have a filter selected. Users can have multiple filters applied within a single category, so the number displayed may not match the total number of filter tiles displayed.
- “Assign Inspection” option added to “Summary” and “SOS” tabs
 - There are two new places that users can now assign an inspection for their asset. This option links to Cat Inspect and prepopulates information about the asset. The “Assets: Health” page displays a “Summary” tab, and individual tabs for each of the different “Health” related items. Users can now assign an inspection for an asset from the fleet level “Actions” menu for “Fault Codes” and “SOS” items. Those items that display on the “Summary” tab because of an “SOS” or “Fault Code” item will also have the “Assign Inspection” option in the “Action” drop-down on the “Summary” tab.
- Ability to edit a “Backlog” maintenance task
 - Users who have “Backlog” maintenance tasks entered for an asset are now able to make edits to the details entered for the “Backlog” task. By clicking the “pencil” icon, an “Edit Backlog Item” modal opens where the user can make updates to the information currently stored for the “Backlog” maintenance task.
- “Asset Health Snapshot” section added to several My.Cat.Com emails
 - An “Asset Health Snapshot” section has been added to provide more data to the dealership which aids in understanding what may be going on with the asset from the last 30 days.
The following dealer emails have been enhanced:
 1. “Schedule General Service”
 2. “Schedule SOS Service”
 3. “Schedule Maintenance Service”
 4. “Schedule Fault Code Service”
 5. “Schedule Inspection Service”
- Maintenance task “type” icons added to “Maintenance” screens
 - New icons have been added to several “Maintenance” screens, to visually provide an indicator to users as to the “type” of maintenance task that the entry is – they are the following:
 - “Service Level” = a “star” icon
 - “Independent Interval” = a “circle” icon
 - “Backlog” = a “triangle” icon
 - “Major Component” = a “diamond” icon
 The color of the “type” icon corresponds to the “status” of the maintenance task:

- Red = “Overdue”
- Orange = “Upcoming”
- Green = “Completed”

August 2022:

Fix for Session Error when Logging out via External Cat Applications

- This fix ensures a log out action on external Cat Applications also logs the user out of MCC

Fix to the Asset Removal Email Body & Grammatical Errors

- This fix ensures email body is populated with applicable information related to the asset

July 2022:

Fix for Assets Overview Timeline not Presenting First Day in Date Range

- User selected date range will present all days in Timeline & Dashboard views

June 2022:

- **Fix for “User Fleet Access Granted” Email to include all Customer Admins**
 - All Customer Admins are now included in Auto-Fleet Access Notifications
 - Auto-Fleet Notification Method Configurable via Dealer Configuration Page

* Auto-Fleet Access Notification Method

- Always send fleet access notifications both to the dealer and to customer admins.
- Only send fleet access notifications to the dealer when there is not a customer admin.
- Only send fleet access notifications to customer admins.

- **Fix for Language Preference Passover Issue via Authentication & Sign-Up Pages**
 - Fix an issue where users who changed their language preference in user authentication or sign up process was not being honored
 - Due to the issue, the users language was defaulted to English.

May 2022:

- **Fix for CC Email addresses removed when more than two email addresses in "TO" field**
 - The email addresses entered in the "CC" field are not removed when more than two email addresses are in the "TO" field.
 - This issue was originally found in the Dealer Admin Invitation acceptance email.
- **Fix for Error Displayed on "Manage Customer Users Page" when trying to "Resend Invite"**
 - When a user has attempted to accept an invitation and an error occurs during the processing of the invitation, this invitation is no longer valid and must be resolved by a Cat administrator. Since this invitation is no longer valid it can only be cancelled and cannot be resent or modified. In this rare event, we will only show the Cancel option."
 - Consistent display on the "New User Invitations" & "Manage Customer Users" pages - invites that are "inactive".
 - MCC shows the invite on both the "New User Invitations" & "Manage Customer Users" pages - even if the invite has been attempted.
 - Under "Actions", the options to "Resend" or "Edit" the invitation have been removed - leaving only the "Cancel" option.

April 2022:

- **Maintenance – Update Tool-tip Text for "Reset to Factory Settings" when not available**
 - When the "Edit Maintenance Settings" modal shows that the user can "Reset Tracking" for the asset, but they cannot "Reset to Factory Settings" – the tool-tip that displays for the "Reset to Factory Settings" link should read: "Reset to Factory Settings is not available for this asset."



- **CAT global "sign-up" page sends MCC User's Language Preference**
 - When a user has made a user language selection on the CAT global "sign-up" page, the selected language is sent to MCC when the user is completing "Step 1" of the MCC registration flow.
 - When MCC is sent the user's preferred language from the "sign-up" page, this language is set as the user's preferred language in MCC – and the remaining steps in the MCC registration flow are displayed in the preferred language, and all emails are sent in the preferred language.
- **"Utilization Report" Download in French**
 - When you download the "Utilization Report" in English, "Working Fuel Burn" is correctly displayed. However, when you switch it to French, only the first digit of the "Working Fuel Burn" is displayed

- The issue for languages that use a space as a numeric thousands separator was resolved (ie. French).
- Utilization Report" download should show complete "Working Fuel Burn".

March 2022:

- **Maintenance – Update Tool-tip Text for “Reset to Factory Settings” when not available**

- When the “Edit Maintenance Settings” modal shows that the user can “Reset Tracking” for the asset, but they cannot “Reset to Factory Settings” – the tool-tip that displays for the “Reset to Factory Settings” link reads: “Reset to Factory Settings is not available for this asset.”

Validate User Option – No Existing DCN's

- When a customer user who is already UCID Validated requests a new Dealer association in My.Cat.com and that dealership does not have any existing DCNs associated to that customer users UCID organization, there will still be a “Validate User” option in the Actions drop down. However, when the "Validate User" option is selected a new popup "No DCNs Exist" modal will display with this information:

Sorry, since your dealership doesn't have any existing Dealer Customer Numbers (DCNs) with this company organization, you are not able to setup the user within [My.Cat.com](https://my.cat.com). Please investigate this customer user account or setup any new DCNs if appropriate in the CAT Customer Admin Tool here: mycustomer.cat.com.

January 2022:

- **Batch Notification Notifications Not Sending to Multiple Email Addresses**

- A dealer user reported they are not getting the Asset ID update email notifications.
- The users email address is listed in the correct place in MCC EQUIPMENT NOTIFICATION > Change Asset ID.
- The Dealer has all of their BATCH NOTIFICATION types checked to receive a daily email.
- The daily email is being sent but only to the first email address listed under EQUIPMENT NOTIFICATION > Change Asset ID or possibly the "General Email Address for the Dealership".
- MCC is not sending the batch email to every email address signed up for EQUIPMENT NOTIFICATION > Change Asset ID and likely should if that is the business rule.
- **Expected Results:** Emails are sent to the appropriate email addresses based on how the dealership has things configured
- The "Recipient" field is updated to point to the correct data/email addresses.

- **Null Pointer Exception for Tasks Linked to Un-validated Assets**

- It was reported that when a user creates a task and links it to an un-validated asset, the email generated for that task creation shows an empty "Asset Information" Section.
- Along with this empty asset information section, the user is unable to share a task with anyone.
- After the fix, there are no errors. The email contains "Asset Information" & the "Share Task" functionality works successfully.

- **Duplicate “Telematics Device” field displayed in “Subscription” tool-tip**



- It was found that MCC was duplicating the “Telematics Device” field (in the tool-tip) for assets on the “Fleet List” and “Asset Details” pages.
- The duplicate “Telematics Device” field happened when the device is a daily upgradable telematics device.
- Now, the “Telematics Device” field only appears once in the “Subscription” tool-tip for a single telematics device.
- **“Global Search” Invalid Serial Number due to trailing space**
 - Dealer had reported not seeing any asset details after selecting an asset from the global search results (MCC allowed a space in the global search).
 - MCC now removes any trailing or leading spaces after the user clicks “Search”.
- **My.Cat.Com Emails – “Contact Information” Duplicated in “Schedule Inspection Service” and “Schedule General Service” Emails**
 - Users found that the "Contact Information" section was listed twice in the "Schedule Inspection Service" and “Schedule General Service” emails. Instead of “Inspection information”, we were seeing contact information.
 - After the fix, the “Schedule Inspection Service” email only displays the “CONTACT INFORMATION” section once, and displays the “INSPECTION INFORMATION”.
 - In addition, the “Schedule General Service” email now only displays the “CONTACT INFORMATION” section once.

October 2021:

- **Maintenance – Re-Implement a Maximum Number of “Steps” and “Parts”**
 - The initial maximum number for both “Steps” and “Parts” is set at 100.
- **Fixed the Fault Code Links to SIS2.0 from My.Cat.Com fault code pages**
 - Incorrect CID and SPN FMI mapping has been fixed to yield proper search results in SIS2.0
 - EID codes were not affected

August 2021:

- **Incorrect Model Number in MCC**
 - The Cat Model number for some assets in My.Cat.Com was showing one way, but elsewhere the safe-source model number was not being evaluated correctly.

July 2021:

- **Maintenance – Remove Limit on Number of Interval Steps Allowed**
 - A user can now associate as many “steps” to a Maintenance interval as they desire. There should no longer be a limit – so the “Add Step” button should never be disabled.

- **Remove Customer Name & UCID from Non-Customer Specific PDF & Excel Downloads**

- The PDF and Excel downloads that are not customer specific (ie DEALERSHIP TASKS, MANAGE CUSTOMERS, REGISTRATION REPORT, etc) erroneously contain the name of the selected customer
- **Expected Results:** Don't display a customer name and UCID

June 2021:

- **Remove "Mongolian" from the list of supported languages in MCC**

- Today, when a customer has selected "Mongolian" as their language in settings - the My.Cat.com still displays in English.
- For "Mongolian", the content on My.Cat.com is not translated into Mongolian, it just passes the language code through to SOS.
- "Mongolian" should not appear as a language option in drop down lists anywhere in MCC.

- **Dealer initiated Invite & Add user email - Dealership name & Email only**

- **Flow #1: When a Dealer Admin invites:**

The text of the "Register for My.Cat.com" email has been updated so that the current text that provides the Dealer Admin user's name and their email address is changed to only display the "Dealership Name" and the "General Email Address for the Dealership".

The "General Email Address for the Dealership" is pulled from the "Dealership Configuration" page.

The text in the email displays as shown below:

"Contact <Dealership Name> with any questions at <General Email Address for dealership>."

- **Flow #2: When a Dealer adds an existing (pre-validated) user:**

The text in the "Welcome" email has been updated to no longer display the name of the Dealer Admin user the granted access to My.Cat.com.

The following text has been replaced in the email:

"You have been granted access to My.Cat.com by <Dealer Admin>"

With this new text:

"You have been granted access to My.Cat.com by <Dealership Name>".

The existing functionality has been left alone for Customer Admins. (ie. still displays the name for Customer Admin who added the user in the "Welcome" email)

- **Restrict Email Domains for Enterprise Employee Users**

- Email domains that are entered in the MCC registration/onboarding flow (specifically “Step 1”) have been restricted to not allow the following domains:
 1. cat.com
 2. perkins.com
 3. solarturbines.com
 4. progressrail.com
 5. mwm.net
 6. fgwilson.com
 7. kempervalve.com
 8. anchorcoupling.com

May 2021:

SMU Last Update Field not Populated for SMU Miles / Kilometers

- The last update field is populated the same as the hours when SMU type is Miles / Kilometers

Update/Remove SIS links in My.Cat.Com

- The SIS Web (Legacy) Quick Link has been removed from the “Overview” page (keep the SIS 2.0 Quicklink).
- The “NEW” text from the “SIS 2.0” Quick Link text on the “Overview” page has been removed.
- The “SIS Legacy” Serial number specific Link/card has been removed from the “Toolkit” page.
- The “(NEW)” text from the existing SIS 2.0 Toolkit card on the “Toolkit” page has been removed.

Timestamp Inconsistency in Downloaded XLS files (UTC)

- **Issue:** When downloading the Fault code data in XLS format, the downloaded file shows different time than the time displayed in My.Cat.com. My.Cat.com shows UTC time and downloaded file shows CDT time.
- **Fix:** Downloaded XLS file should show time in UTC.
 - The service used for exports has been updated so that XLS files show the date/timestamp for in UTC instead of CDT.
 - The column header in the XLS download for “Date” has been updated to display as “Date (UTC)”.

April 2021:

- **Remove Dealer/Admin name from “Account Validated” and “Account Validation Cancelled” Emails**

- The “Account Validated” email has been updated to no longer display the name of the Dealer/Admin user who completed the validation.
- The “Account Validated” email now reads as follows:

- **Update “End User Agreement” Registration Page with new Text and Hyperlink**
 - first checkbox text under the “End User Agreement” has been updated to read: “I have read and agree to the My.Cat.Com End User Agreement.”
 - The second checkbox text under the “End User Agreement” has been updated to read: “I have read and acknowledge the [My.Cat.Com Privacy Notice](#) and [Data Governance Statement](#).”
 - The “My.Cat.Com Privacy Notice” text is a hyperlink to the Privacy Notice. This is the same as the “Privacy” link at the bottom of the page.
 - The hyperlink for the “Data Governance Statement” text is: <https://www.caterpillar.com/dataprivacy>

March 2021:

- **“Manage Customer Users” – Display the Name of Original Invite Sender (from MCC Data table)**
 - The displayed name of the “Administrator” on the “Invitations” tab of the “Manage Customer Users” tab
 - When there is no name in the database record (if the original account is no longer existing), then the screen displays “Unknown”.
- **Mobile Date Range Selector updates**
 - The framework code for “Date Range” has been updated so that the range that can be selected is the same in mobile as it is in the desktop (non-mobile) view.
 - The selected “Date Range” is retained when a user returns to the date picker to select a new date range.

February 2021:

- **SOS Sample Missing Status Error**
 - End users get an error which prevents them from seeing any of their SOS samples.

- **Add Validation Message for "Service Meter" for Non-Manual Maintenance Assets**
 - The same field validation messaging has added for non-PMM Manual Maintenance assets that is currently displayed for PMM Manual Maintenance assets: **"Enter a value less than or equal to 999999999"**

January 2021:

- **"Utilization" – if "Idle Hours %" or "Working Hours %" is over 100%, then bad data flagged**

- As any user role on the Asset Details: Utilization screens - for both Hours & Fuel tabs:

If the idle hours % value for a date is greater than 100% then:

The text for the row is in red font.

The alert icon is displayed after the date, with the suspected bad data tool tip text.

The data points for the date are not displayed in the chart.

If the working hours % value for a date is greater than 100% then:

The text for the row is in red font.

The alert icon is displayed after the date, with the suspected bad data tool tip text.

The data points for the date are not displayed in the chart.

- **Ownership Status is now consistent between "Details" and "List" pages**

- If an asset is found in both CDDW and CCDS then the Ownership value is determined by the ownership status value the dealer sent to CDDW as long as the DCN matches in CCDS and CDDW.
- If an asset is found in CDDW but not in CCDS then the Ownership value is determined by the ownership status value the dealer sent to CDDW as long as the DCN is correct.
 1. If the asset is un-validated, then use whatever the customer specified.
 2. Else if the asset is in CDDW:
 - a. If one or more are Owned, then Owned.
 - b. Else if one or more are Leased, then Leased.
 - c. Else if one or more are Rented, then Rented.
 - d. Else Unknown.
 3. Else Unknown.

- **Fixed the validation error message for "User Selector" in the "Add User" modal**

- The error message for that displays for the "User Selector" field in the "Add User" modal only display if the entered/selected user is already a Dealership User.

- The error message only includes the user name for the user that is already a Dealership User – not all of the users that have been added.
- **Telematics Invoices - Don't calculate outstanding balance value**
 - As any user with access to the **Operations: Telematics Invoices** screen:

For any invoice row with 1 or more credit memo's the outstanding balance value displayed in the MCC UI matches the outstanding balance value displayed in the associated invoice PDF.
- **Removed the multiple language support for the “Learn More” link**
 - As any user role, on the:

Overview screen Subscription Summary box:
If the user's selected language is English then this link is displayed: "Learn more about telematics subscriptions".

- **UI: Validate Cat Serial Number for QR Code**
 - For an asset with Make: CAT - the entered serial number value must be a valid Caterpillar serial number.
- **Telematics Invoices: change default date range to 6 months**
 - As any user granted access to the Operations: Telematics Invoices screen.
 - Upon first load of the screen the default date range is 6 months.

October 2020:

“Invite New Users” - Customer Admin Users Verify if UCID Still Exists

- If an email address has been entered into the “Invite New User” modal, and it has an invitation already associated to it – then check to see if the UCID that invitation was tied to still exists.

- If the UCID still exists, then the Customer Admin user is not able to submit another invitation to the same email address – since one is already pending.
- If the UCID has been deleted, then the invitation associated to the email address is cancelled – and the Customer Admin user is able to submit a new invitation for that same email address.

“Registration Report” Download – Include the “All” Row in Download File

- The XLS and PDF files for the download of the “Registration Report” (Dealer Report) includes all of the same data that is shown on the screen.
- If the “All” row is shown on the screen, then it is included in both the XLS and PDF downloaded files.

September 2020:

- **My.Cat.Com Emails – Add “Customer Contact” Info to “Request Service” Emails**
 - Each of the “Schedule Service” emails that are sent to dealers include a “Contact Information” section with information related to how to contact the customer who has scheduled that particular service. The emails that have the customer “Contact Information” included are:
 1. “Schedule Fault Code Service”
 2. “Schedule General Service”
 3. “Schedule GPS Rollover Service”
 4. “Schedule Inspection Service”
 5. “Schedule Maintenance Service”
 6. “Schedule SOS Service”
 7. “Call Off Rental”
 8. “Create Telematics Subscription”
 9. “Upgrade Telematics Subscription”
 10. “Quote Customer Value Agreement”
 11. “Quote Extended Protection Plan”
- **Password Change from “Account Settings” was not working as expected**
 - Previously, no confirmation of a successful password change was displayed and the password was not changed to the new password.
 - Now, the user is shown a success message when the password has been successfully updated – and the password is updated to the new password.
- **“Date Range” Selector (iPad) – Blank (Black) Tool-Tip Displays Briefly on Hover**
 - Previously, when a user viewed a My.Cat.com page with a “Date Range” selector on an iPad – hovering over the “Date Range” text resulted in a blank (black) tool-tip displaying briefly on the screen.
 - The reason for this “Date Range” tool-tip displaying on the iPad has been determined, and the solution has been implemented for all pages that have a “Date Range” selector.
- **“Manage Customers” Downloads – Do Not Include the “View Fleet” Text in Downloads**
 - The “View Fleet” text has been removed from the download of information from the “Administration: Manage Customers” page.
 - The XLS file’s “NAME” column displays only the customer name, without the “View Fleet” text.
 - The PDF file’s “NAME” column displays only the customer name, without the “View Fleet” text.
 - The “Administration: Manage Customers” page continues to display the “View Fleet” link text. Only the download files remove the “View Fleet” text.
- **Maintenance – “Next Service” Does Not Display if Not Within the Default Timeframe**
 - On the “Assets: List” page, the “Next Service” for each asset in the fleet list is displayed within the “1-week back, 1-year forward” timeframe.



- On the "Asset Details" page, the dashboard displays the "Next Service" for the asset within the "1-week back, 1-year forward" timeframe.
- The "Due Date" for the first maintenance service shown in the table for an asset on the "Asset Details: Maintenance" page already shows the date the service is due - but it may not be the same as what is shown on the "Assets: List" screen & "Asset Details: Dashboard", as the table on the "Asset Details" screen has it's own "Date Range" selector.
- **Manage Dealer Users - dealer code mapping issue**
 - Previously, there were Dealer users added to a dealer code that had been mapped to a different dealer. They would get an error upon logon, and were unable to use My.Cat.com.
 - The "Administration: Manage Dealer Users" screen has been updated so that Caterpillar Admins and Dealer Admins cannot add users to a dealer code that has been mapped to a different dealer.
- **Sign Up Password Validation Error**
 - Previously, some Dealer users were unable to sign up their customers with My.Cat.com – and they were getting a generic "contact support" error.
 - The password the user was using appeared to be meeting the minimum password requirements per the UI (specifically the Special Character item), but it really wasn't because there wasn't a special character being used in the password. The My.Cat.com was treating "p" as a special character.
 - There is now a more specific message displayed to the user when the password does not meet the minimum requirements.

August 2020:

- **Relaxation of duplicate interval names for Independent Intervals and Major Component Intervals**
 - My.Cat.Com has been updated to allow a user to use a duplicate name for "Independent Interval" and "Major Component" intervals that are designated as "Occurs only once" ("one time only"). If a duplicate name is used, then each of the occurrences needs to have a different "First Occurrence" associated to it.
 - With the change to allow a duplicate name, the validation for the name in the "Add" modal happens upon the user clicking the "Save Changes" button – so the system is able to determine if the "Occurs only once" checkbox has been selected.
 - Duplicate interval names are allowed for: (1.) "Independent Intervals" marked as "Occurs only once", (2.) "Major Component" intervals marked as "Occurs only once", and (3.) "Backlog" intervals.
 - When a user is attempting to "Copy" an interval from any of the three scenarios listed above, then they no longer are shown a "Resolve Conflict" button – as there is no longer be a conflict with the duplicate name (it is now allowed).
 - The "First Occurrence" field takes into account both the numeric value and the unit of measure when determining if there is a duplication.

July 2020:

- **Display the "Reset to Factory Settings" link as inactive if reset is not available**
 - Within the "Edit Maintenance Settings" modal, the business logic has been updated to show the "Reset to Factory Settings" link as grayed out (not selectable) when the current settings match Cat's schedule.
 - When the user hovers over the icon while the "Reset to Factory Settings" link is inactive, the tool-tip reads: "Reset is not eligible due to the current schedule matching Cat's schedule."
 - The inactive "Reset to Factory Settings" link is displayed if the asset is "multi-model" (it has multiple builder files). The tool-tip in this scenario reads: "Reset is not eligible due to multiple models of this asset."

- The inactive "Reset to Factory Settings" link is displayed if the asset data does not come from SMI. The tool-tip in this scenario reads: "Reset is not available for this asset."
- **Update MCC "Invite" emails to not link the "My.Cat.Com" text**
 - For the "Register for My.Cat.Com" and "Sign In to My.Cat.Com" emails we don't want the "My.Cat.Com" text to be turned into a link automatically by Outlook.
 - The resource bundle has been modified such that the "My.Cat.Com" text is not turned into a link within these two emails, nor in the footer of any of the MCC emails.

June 2020:

- Standardized display of text links within My.Cat.Com
 - Text links throughout My.Cat.Com now display in a consistent manner. If text is a link, it will display as blue text. When the user places their cursor over the blue text, the link will also be underlined. This update should make it easier for users to identify text as a link.
- Default of the user's email address as their CWS ID when signing up for My.Cat.Com
 - Within the "Sign Up" screen for My.Cat.Com, the email address entered will be defaulted as the "Username" as well. The "Username" can still be changed if desired – but once an email address is entered in the "Email" field, the "Username" field will automatically be populated with the same email address.
- Sync of Dealer Management Tool (DMT) deletions with new users in Dealer Registration Report
 - A new My.Cat.Com batch job will run daily to sync the "Registration Report" to remove any users that have been deleted by dealer users in the Dealer Management Tool (DMT). This will keep users from being reported as "waiting for dealer validation" on the "Registration Report" – when the dealer will not be validating. The "Registration Report" will be updated to "Cancelled" – and the "Unvalidated Days" column count will display a dash "-".

OTHER/OPERATIONS

Changes that impact availability, installation, or support for the product.

March 2022:

- **Dealer Admin (inviter) cc'd on "Invitation Accepted" email**
 - When a MCC "Invite" is initiated by a Dealer Admin (not a Customer Admin), the Dealer Admin is cc'd on the "Invitation Accepted" email.
 - The Customer Admin is not cc'd on the "Invitation Accepted" email, as it has information/instructions that this person does not have access or capabilities to manage.
- **No Longer Display "Advice Center" on "Asset Details" page**
 - On the "Asset Details" page, the "Advice Center" section – and all sub-sections - no longer display.
- **Suppress "Fault Code" Data for Assets with Cat Basic subscription per Commercial Product Link Subscription definition**
 - Assets with a VisionLink Cat Basic subscription are not defined to see any of the Fault Code data for Connected assets in MCC as per the Product Link Parts and Service Guide.
 - The display of Fault Code data for Connected assets at the Fleet level, and Asset Detail level has been suppressed– if the asset's subscription is Cat Basic.



- If the asset has a Cat Basic subscription, there is a blue-bar message that displays on the “Asset Details” page telling the user that Fault Code data is not supported for the Cat Basic subscription. They are directed to consult with their dealer if they would like a subscription upgrade.

February 2022:

- **Fuel Guarantee Enrollment for ADSN-N - Validated user & equipment**
 - Newly enrolled ADSN-N assets are required to have the associated equipment UCID match the associated UCID of the person submitting the Fuel Guarantee enrollment request.
 - The enrollment in the Fuel Guarantee program for ADSN-N assets is only granted for Validated users & Validated equipment.
 - If the Equipment UCID, and the user’s/submitter’s UCID do not match – then MCC prevents enrollment in the Fuel Guarantee program.
 - MCC points the user/submitter to contact their Local Dealership for any questions or concerns.
 - The message reads: **"Sorry, please reach out to Dealer <X> to ensure asset ownership and customer user accounts match."**
 - The case check on S/N for enrollment has been removed.
- **“Validate Customer User” email updated with “Customer Admin Tool” text**
 - The text within the “Validate Customer User” email has been updated to reflect the retirement of the UCID tool, and its replacement with the “Customer Admin Tool” (<https://mycustomer.cat.com/>).
 - The 3rd point in the “ACTION REQUIRED” list now reads:

If a new UCID Customer Organization or DCN needs to be created, manage the company hierarchy in the new Customer Admin Tool (https://mycustomer.cat.com), otherwise you can validate the user to their UCID Organization using the My.Cat.com Registration Report or Dealership Task report.
- **Explanatory Note added to “Maintenance Notifications” Modal**
 - Within the “Maintenance Notifications” modal, under the “Email notifications will be sent based on the settings below” text, the following text has been added:

Note: Notifications for assets subscribed to a VisionLink level must be configured in VisionLink.

January 2022:

- **MCC Registration – Move “Dealer Selection” Loading Icons & Wait to Load Page Until Dealers Are Retrieved**
 - The “Loading” icons (yellow bubbles) have been moved from the top of the page, to display beneath the explanatory text on the “Dealer Selection” page.
 - The rest of the “Dealer Selection” page remains blank until the loading has been completed.
 - Once the loading has completed, the user is shown a page with a “Search” field, and a map with the dealer locations marked.
 - After a location/name is entered in the “Search” field, the list of dealers matching the search criteria display in a list – and the map adjusts to focus on the dealers in the returned list.

November 2021:

- **Update Warning Message for Blocked Email Domain as a Customer or Dealer Admin**

- When a blocked/restricted email domain was entered for an “Invite”, the prior error message that was not displayed was not very clear. The user was not told why the invitation has failed (“Invitation failed to send.”)
- When a user enters an email address with a blocked/restricted domain, the warning message now reads:

You cannot register with an email address using any of these domains: cat.com, perkins.com, solarturbines.com, progressrail.com, mwm.net, fgwilson.com, kempervalue.com, anchorcoupling.com

- The blocked/restricted domains are:
 - o cat.com
 - o perkins.com
 - o solarturbines.com

 - o anchorcoupling.com
- When an email with a restricted email address is entered, the system does not try to send the “Invite” email. Only once a non-restricted email address is entered does the system attempt to send the “Invite” email.

July 2021:

- **Update “Machine Component Serviced” List in “Record Service” Modal**
 - o The “Machine Component Serviced” drop-down list has been updated in the following manner:

 - The counts that are displayed for each of the sub-sections under “Health & Maintenance” in the left-nav of the “Asset Details” page have been removed.

September 2020:

- **Operations: Service History – Add Bullet-Points to Display when Multiple "Description" Items Listed**
 - When the "Description" field is included on the page, the separate items are displayed as a bulleted list.
- **Remove the Cat MineStar Health Equipment Insights row from Subscription Summary**
 - On the “Overview” screen, in the “Subscription Summary” box - the “Cat MineStar Health Equipment Insights” row is no longer displayed.
 - “Cat MineStar Health Equipment Insights” subscriptions are included in the “Not Subscribed” count.
