- When Reference Lines are enabled for the Chart and Chart & Table views in Utilization, the Maximum, Average, and Minimum values are based on the number of assets displayed on the pages. Previously, the Maximum, Average, and Minimum values were based on the entire fleet.
- Filters now have dynamic filtering capabilities. When you select the first filter option in the Filters panel, VisionLink dynamically filters the search criteria and options in all other filters. When you select the next filter, you will see filtered results or options that meet the initial filter criteria. Geofence, Group, and Jobsite filters are not affected by dynamic filtering.
- A new column, Filters, has been added to Manage > Reports. The Filters column displays the total count of filters set at the time of scheduling an email report. To view the filter types, select the value in the Filters column.



- An issue with the username and the user access type not displayed in Manage > Users, which was also missing in the report.
- Unable to generate a report.
- A range of data in VisionLink is not matching the data in VisionLink Unified Suite.
- An issue with assets being duplicated.
- User invite page is not loading.
- An issue with incorrect asset status has been resolved under certain conditions.
- Audit Log in Manage > Assets is showing Switch configurations when in real time there are no switch events.
- An issue with the Dealer being unable to remove an asset from the Customer's account.
