AUSTRALIA — MAINTENANCE FOR MINING CVA

- **The Challenge** was to maintain required production, high physical availability, and reliability of an aging fleet of coal mining trucks.
- **The Solution** was a Maintenance for Mining CVA that reduced the maintenance intensity required for the fleet and included Planned Component Rebuilds (PCRs).
- **The Result** was an extension of replacement intervals that improved physical availability; lowering the Total Cost of Ownership (TCO).



BRAZIL — HOSE & COUPLING CVA

- **The Challenge** was to reduce downtime from unexpected hose failures.
- **The Solution** was a Hose & Coupling CVA that provided an on-site stocked hose shop and dedicated dealer technicians for proactive inspections.
- **The Result** was an improved machine uptime due to the prevention of early failures, contamination control, and availability of inventory on site.



CANADA — GET CVA

- **The Challenge** was to shift from a CapEx model to an OpEx solution for undercarriage and GET management.
- **The Solution** was a three year CVA for GET and undercarriage across 16 machines in total, with dealer-managed wear parts service solutions.
- **The Results** are measured by extended component life, consistent inventory, and lower Total Cost of Ownership.

- **The Solution** was a CVA for all GET on two hydraulic mining shovels, with parts changeouts and a dedicated dealer wear specialist to measure and control cost per ton throughout the equipment lifecycle.
- **The Results** are measured by extended GET life, predictable changeout costs, reduced cost per ton, and lower overall GET parts costs.



NORWAY — UNDERCARRIAGE CVA

- **The Challenge** was to reduce maintenance downtime and provide technical expertise.
- **The Solution** was an Undercarriage CVA with on-site undercarriage wear management support.
- **The Result** was the reduction of machine downtime by eliminating existing issues through product innovation, high component reliability, the availability of an experienced service team, and extended warranty support.



UNITED STATES — POWERTRAIN CVA

- **The Challenge** was to provide predictable costs and reduce the risk of major component failures.
- **The Solution** was a CVA across 224 machines with PM parts, equipment health monitoring, and "not-to-exceed" pricing on powertrain and powertrain components.
- **The Results** are measured by predictable maintenance costs as well as the reliability and performance of equipment.
