LIMITED MANUFACTURER'S WARRANTY

1. For one (1) year from the date of original purchase, TRIXIE Pet Products ("TRIXIE") warrants to the purchaser of this product that, should it prove defective by reason of improper workmanship and/or material, TRIXIE will repair or replace, at its option, any defective part of the product, without charge for the part or for shipping. Replacement parts are warranted for the remainder of the original period.
2. THIS WARRANTY DOES NOT COVER defects in the product caused by any animal, any physical abuse to or misuse of the product, any damage caused by the original purchaser or any third party, or any defects arising or discovered more than one (1) year from the original retail purchase date.
3. HOW TO OBTAIN WARRANTY SERVICE:
 - A. The purchaser must call TRIXIE's customer service line, 817-738-0119, to report the alleged defect to a representative or obtain missing parts.
 - B. The customer service representative will determine if this warranty covers the defect, and if it is, will authorize and instruct the purchaser on how to obtain corrective action.
 - C. TRIXIE may require the purchaser to present the sales receipt or other proof of purchase prior to authorizing any return or replacement. No returns or replacements will be permitted without proper authorization. If a return or replacement is authorized, you may be requested to return the item to TRIXIE or to make the item available for pick-up by TRIXIE.

ANY EXPRESS WARRANTY NOT PROVIDED IN THIS WARRANTY DOCUMENT AND ANY REMEDY FOR BREACH OF CONTRACT THAT, BUT FOR THIS PROVISION, MIGHT ARISE BY IMPLICATION OR OPERATION OF LAW, IS HEREBY EXCLUDED OR DISCLAIMED. THE IMPLIED WARRANTIES OR MERCHANTABILITY AND OF FITNESS FOR ANY PARTICULAR PURPOSE ARE EXPRESSLY LIMITED TO A TERM OF ONE (1) YEAR. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.
