



2) Remove the nut, bolt and washers from the THROWING ARM ASSEMBLY shown in diagram 2 with two 9/16" wrenches. Align the THROWING ARM ASSEMBLY to the BASE ASSEMBLY. Attach the two bolts and washers and tighten. (The bottom plate on the BASE ASSEMBLY is threaded). After the THROWING ARM is tightened to the BASE ASSEMBLY reattach the nuts and tighten securely.




4) Attach the MICRO ADJUSTMENT and the RELEASE ARM BLOCK into the numbered hole based on the desired speed shown on the chart located on the TOP SHIELD of your machine.



3) Remove the nut, bolt and two washers from the BASE ASSEMBLY shown in diagram 3 with two 9/16" wrenches. Align RELEASE HANDLE to the inside the "U" channel of the BASE ASSEMBLY. Insert bolt and washer and attach washer and nut. Tighten secure but **DO NOT OVER TIGHTEN.** The RELEASE HANDLE should move freely but not have side to side movement.

Remove the two screws from the top of the RELEASE HANDLE with a phillips screwdriver. Attach the TOP SHIELD and secure with the two screws.



5) Attach the optional SPIKES to the FRONT LEG

FINAL STEP: Attach the SPRING to the numbered hole on the POWER PEDAL for the desired speed based on the speed chart on the top shield. To extend the life of the spring detach the SPRING from the POWER PEDAL when not in use.

CONNECTOR




Any replacement product may be either new or like new, provided that it has function-ability at least equal to that of the product being replaced. To obtain service under this warranty, return product to place purchased.


