INSTRUCTIONS:

- 1. If choosing to insert one of the face inserts, this should be placed in the clear pouch on the front of the unit prior to inflating. If, after the bag has been inflated, you wish to place an insert in the clear pouch, you must first release enough air from the bag to easily place this item inside its pouch.
- 2. Fill base with water or sand.
- 3. Open the air valve on the side of the bag.
- 4. Inflate the bag with standard air pump (not included). Fill until bag is upright and most of the wrinkles have straightened out.
 - Do not over inflate bag. You should be able to depress your finger in to a depth of about 2" when fully inflated.
- 5. Close air valve and push gently into the body.
