

## AEO WIN YOUR FAVORITES SWEEPSTAKES

### OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS AND AN AMERICAN EAGLE OUTFITTERS ACCOUNT ARE NECESSARY TO PARTICIPATE.**

**The Sweepstakes is subject to and governed by these Official Rules (the “Official Rules”). By entering or otherwise participating in the Sweepstakes, you agree to be bound by these Official Rules.**

The WIN YOUR FAVORITES Sweepstakes (the “Sweepstakes”) consists of ten (10) sweeps (“Daily Sweeps”), each on consecutive days, starting at 6:00 a.m. Eastern Daylight Time (“EDT”) on 11/2/2017, and ending at 5:59 am Eastern Standard Time (“EST”) on 11/12/2017 (the “Entry Period”). For submission of an entry, method of entry and other Sweepstakes details, see below. The sponsor of the Sweepstakes is AEO Management Co. (may be referred to as “American Eagle Outfitters”, “AEO”, or “Sponsor”), 77 Hot Metal Street, Pittsburgh, PA 15203.

**ELIGIBILITY:** Sweepstakes is open only to legal residents of the fifty (50) United States of America and the District of Columbia and Canada (except Province of Quebec) (collectively, the “Eligibility Area”), who as of the date of their participation into the Sweepstakes are eighteen (18) years of age or older. Employees of Sponsor, and its affiliates, suppliers, distributors, dealers and advertising and promotional agencies and the immediate family (defined as spouse, child, parent, grandparent and sibling) and household members of such employees whether related or not are not eligible to receive the Prize (defined below). Void in U.S. territories and possessions the Province of Quebec, overseas military installations and where prohibited or restricted by law. A Prize won by an individual at least eighteen (18) years of age, but considered a minor (“Minor”) in his/her legal jurisdiction of residency will be awarded in the name of the Minor’s parent or legal guardian, who will be responsible for fulfilling all requirements imposed on Winners (defined below) set forth herein. All federal, state, provincial, and local laws and regulations apply. Sponsor reserves the right to disqualify any Entrant (as defined below) if it has reasonable grounds to believe the Entrant has breached any of the Official Rules. A Minor who is eighteen (18) years of age and otherwise eligible to participate in the Sweepstakes must get his or her parent’s or legal guardian’s permission before entering the Sweepstakes. **HOW TO ENTER THE SWEEPSTAKES:** To enter, you must have an account with American Eagle Outfitters (an "Account"). If you do not have an Account, go to [www.ae.com](http://www.ae.com), click on "My AEO" in the upper right hand corner of the site, and then click on "Create Account" in the corresponding drop down menu. Create an Account according to (and by following) the instructions on that website. Creating an Account is free. Please note that you must accept and agree to comply with the Sponsor's website terms and conditions in order to create an account.

To add a product to your Account's "Favorites List" ("Favorites List"), either (1) click the heart icon located next to the product on the product description page, or (2) click (and fill in) the heart icon located in a product image on the category (or search results) list page. Once you click on a heart icon, the corresponding product will be saved to your Favorites List.

1. During or prior to the Entry Period, create an American Eagle Outfitters account ("Account"), per the above instructions, if you do not already have one;
2. During or prior to the Entry Period, sign in to your Account and **add at least five (5)** American Eagle Outfitters and/or Aerie products ("products") to your Favorites List, per the instructions above.

**NOTE:** To confirm/check the number of products on your Favorites List, after signing in to your Account, click on "Favorites" in the upper right navigation of [www.ae.com](http://www.ae.com).

At the end of each Daily Sweeps Period (see **Daily Sweeps Period Schedule** above), all Accounts that have at least five (5) products saved in its respective "Favorites List" will receive an entry into that Daily Sweeps Period.

Each an "Entry" and collectively "Entries".

Limit: one (1) Entry per person, per Daily Sweeps.

**NOTE:** Entrants are not required to change, swap or otherwise edit their Favorites List throughout the Entry Period in order to remain eligible for the next (or for any remaining) Daily Sweeps. The Sponsor's clock will be the official timekeeper for this Giveaway.

**PRIZE AND ITS APPROXIMATE RETAIL VALUE ("ARV"):** Ten (10) prizes (collectively, "Prizes", each individually a "Prize") will be awarded. Each Prize consists of one (1) \$500 USD AEO gift card. The approximate retail value ("ARV") of the Prize for each Daily Sweeps is \$500 USD, and the total ARV of all Prizes in the Sweepstakes is \$5,000 USD. If any Winner is eighteen (18) years of age, but under the age of majority in his/her state/province of residence (a "Minor"), his/her Prize may be awarded his/her parent or legal guardian ("Parent").

Sponsor shall have no liability for any Winner notification that is lost, intercepted or not received by a Potential Winner for any reason.
