

US Cookie Collection Notice

EFFECTIVE AS OF JULY 1, 2022.

American Eagle Outfitters, Inc. and our affiliates and subsidiaries (collectively "AEO", "we", "us", or "our") permit service providers and trusted partners to collect and receive your personal identifiers (such as device identifiers), Internet activity information (such as browsing history), and inference data (such as inference product preferences) through our emails and platforms (including our websites, mobile applications and other AEO-controlled properties that display or link to this notice) (collectively, the "Platforms") through cookies, pixels, or similar technology and from us so they may provide services to us and you, as detailed in this Cookie Collection Notice (this "Notice"). AEO Information Collection: We use our own cookies, pixels, or similar technology to make sure that the Platforms function properly (e.g. for login or registration purposes, language preferences, shopping baskets, etc.), and for statistical, social, targeting and commercial purposes. Additionally, we permit other parties to collect information in a similar manner to perform services for you and us.

Service Provider Information Collection: We permit service providers to collect personal information directly from you when you use our Platforms and when we provide your information to them; they are permitted to use the information only to provide their services to us. Those services include providing certain functionality (such as videos, social media, and product reviews), analyzing the usage of our Platforms so we can improve them, and customizing content and advertising on the Platforms. You can see more detailed information about such service providers in the table below.

Trusted Partner Information Collection: When we permit other trusted partners that are not service providers to use cookies, pixels, or similar technology to collect or receive personal information about you, they will use the information to provide their services to you and us, but they may also use the information for their own business purposes as explained in their privacy notices. Those services include analyzing the usage of our Platforms so we can improve them and customizing content and advertising on the Platforms. Data Matching: Our service providers and trusted partners may collect and combine information collected on our Platforms with other information about your online activities over time, on other devices, and on other websites or applications, if those websites and apps also use the same service providers and trusted partners.

PERSONALIZATION

Please note, even if you choose to restrict or modify your settings, you may still see or receive AEO advertisements via our Platforms and on other sites, but such advertisements will not be personalized based upon your browsing history.
