

## COOKIES NOTICE

EFFECTIVE AS OF December 6, 2018.

This Cookies Notice (this “**Notice**”) describes the way American Eagle Outfitters, Inc. (“**AEO**”, “**we**”, “**us**”, or “**our**”) use cookies and other similar technologies to collect information on [www.ae.com](http://www.ae.com) (the “**Website**”) and/or other technology platforms such as our interactive features and applications (“**Other Platforms**”). Please note, AEO is a United States of America entity and part of a larger group of companies. For additional information on how AEO uses, stores and shares your information, please visit our [Global Privacy Notice](#).

### 1. HOW AEO AUTOMATICALLY COLLECTS INFORMATION.

- a. **Usage Information.** Whenever you visit or interact with the Website and/or Other Platforms, we, as well as third-party advertisers and/or service providers, use a variety of technologies (including cookies, as explained in **Section 2** below) that automatically or passively collect information about how the Website and/or the Other Platforms are accessed and used (collectively, “**Usage Information**”). Usage Information is browser type, device type, operating system, application version, the page served, the time, your geolocation, the preceding page views, and your use of various features, how you interact with the Website or Other Platforms and/or applications. This information helps us keep our Website and/or Other Platforms fresh, relevant and interesting to our visitors and allows us to tailor content to a visitor’s interests.
- b. **Device Identifiers.** We or our service providers automatically collect your IP address or other unique identifiers (“**Device Identifier**”) for the device you use to access the Website and/or Other Platforms (*e.g.*, computer, mobile phone, tablet or other device) (each, a “**Device**”). A Device Identifier, which is part of the Usage Information, is a number that is assigned to your Device when you access a website or its servers. Our systems identify your Device by its Device Identifier. We use a Device Identifier to administer the Website and/or Other Platforms, help diagnose problems with our servers, analyze trends, track users web page interactions, help identify you (including your shopping cart), and gather broad demographic and related information.
- c. **Cookies and Pixel Tags.** The technologies used on the Website and/or Other Platforms to collect Usage Information (including Device Identifiers) are cookies (described in further detail in **Section 2** below), mobile analytics software and pixel tags (transparent graphic image, sometimes called a web beacon or tracking beacon, placed on a web page or in an email, which indicates that a page or email has been viewed). We also use cookies to associate you with social networking sites like Facebook and Twitter and, if you so choose, enable interaction between your activities on the Website and/or Other Platforms, and your activities on such social networking sites. We, or our vendors, place cookies or similar files on your Device for various purposes (please see below), including for security purposes, to facilitate site navigation and to personalize your experience, while visiting our Website and/or Other Platforms (such as allowing us to select which ads or offers are most likely to appeal to you, based on your interests, preferences, location, or demographic information). Please note that, technically, a pixel tag may tell your browser to get content from another server; in case you access servers out of our control we cannot guarantee the integrity of that connection.

### 2. COOKIES.

- a. Cookies are tiny text files that are stored on your Device when you visit our Website and/or Other Platforms. Cookies enable us to recognize your Device when you revisit the Website and/or Other Platforms.
- b. We use cookies to help us monitor and improve the security, functionality and usage of the Website and/or Other Platforms and your experience (for example by enabling us to keep track of what you've bought from us and what you’ve done on the Website and/or Other Platforms).

- c. We use both **session cookies** (which expire once you close your web browser) and **persistent cookies** (which stay on your Device until you delete them).
- d. You may refuse the use of cookies by selecting the appropriate settings on your browser; however, please note, if you refuse the use of cookies you may not be able to use the full functionality of the Website and/or Other Platforms. By using the Website and/or Other Platforms, you consent to the processing of data about you by in the manner and for the purposes set out herein.
- e. Additionally we've put our cookies in the following categories, to make it easier for you to understand why we need them:
- a. **Functional Cookies:** Functional cookies are cookies that make sure that the website functions properly (e.g. for login or registration purposes, language preferences, shopping baskets, etc.). Logically, functional cookies are first-party cookies.

- Non-Functional Cookies:** Non-functional cookies are cookies that can be inserted for statistical, social, targeting and commercial purposes. They have nothing to do with the purely technical support of the website. Cookies that serve statistical purposes can be used to examine which pages of the website you visit, where your computer is located, etc. Cookies that serve social purposes enable the user to share the content of the website visited with others directly via social media. Cookies that serve targeting purposes can be used to build up a profile on the basis of your surfing behavior so that the adverts shown are geared to your interests. Cookies that serve commercial purposes record how many and which advertisements are shown to a user. Non-functional cookies may be first-party or third-party cookies.

**g. A Third Party Cookie Example: Google Analytics.**

- i. You can also set your browser to warn you when a cookie is being sent or to remove or reject cookies. For more information on how to set your browser to disable cookies, please keep reading and see Section 3(b) below.
- ii. **If you agree to cookies** from the Website or Other Platforms, we will set cookies on your Device. If you wish to delete such cookies, please refer to your browser "Help" menu.

#### b. How to Set your Browser to Disable Cookies.

- i. Your web browser allows you to:
  - change your browser settings to notify you when you receive a cookie, which lets you choose whether or not to accept it; or
  - Set your browser to automatically reject any cookies.
- ii. Each browser is different, so look at your browser "Help" menu to learn the correct way to modify your cookie settings. If you choose to remove or reject cookies, it will affect many features or services on our Website and/or Other Platform.
- iii. Please note, if you disable or reject technical cookies, some features and services on our Website and/or Other Platforms may not work properly because we may not be able to recognize and associate you with your Account.
- iv. **Please note, in case you have enabled "Do Not Track" (or DNT) in your browser, AEO does not respond to the "Do Not Track" setting in users' web browsers at this time.**
